PH 623-C* REPORTED BRUNO AND WIFE VISITED ATLANTIC CITY, NEW JERSEY, EVENING SEPTEMBER 1, 1962, RETURNING ONE OR TWO AM, SEPTEMBER 2, 1962. BRUNO CONTACTED BY UNKNOWN MALE SEPTEMBER 1, 1962 TO ENLIST BRUNO'S ASSISTANCE IN OBTAINING "SOMEBODY UP HERE (PHILADELPHIA) THAT WILL HANDLE SOME STUFF FROM CAROLINA (ALCOHOL)." BRUNO STATES HE HAS NOT HAD ANYTHING TO DO WITH ALCOHOL FOR FIFTEEN YEARS HOWEVER HE WILL OBTAIN SOMEONE TO PHILADELPHIA WHO IS MEMBER OF THE "FAMILY" WHO CAN BE TRUSTED.
