The attached letter to the Director from the Assassination Records Review Board (ARRB), advises of determinations concerning JFK records. The Swiss government approved the release of the documents this way and the FBI is in agreement with the ARRB determinations. The details of the five foreign government documents have been set forth in John A. Hartingh to Mrs. Morris memorandum dated 12/18/95, which notified CID and NSD of the release of information.

The other documents described in the 12/18/95 memorandum will be addressed in a letter from the ARRB around 12/27/95, which may raise some appeal issues .
