On 3/30/66, WFO source of information [redacted] (protect, reliable), advised SAs JOHN G. GOEDTEL and JOSEPH E. SCULLY that organization described by ENRIQUE LINERER was definitely the original organization known as "Comandos L." [redacted] is traveling to Florida 3/31/66, and returning to Washington, D. C., 4/4 or 5/66. At that time he will be in possession of complete details re organization, and will furnish same to WFO. *RV*

Miami discontinue efforts to identify organization described in re communication.

WFO will report details obtained from GRAMATGES, under caption of "Comandos L, Incorporated." *RV*
