Re San Antonio letterhead memorandum dated 3-10-61 in the case entitled ELOY GUTIERREZ-MENOYO, aka; IS - CUBA, Bufile 105-82298, San Antonio file 105-2118. (u)

The above-mentioned subject was identified by GUTIERREZ MENOYO as a Comandante in the Cuban Army who had been a member of the Second National Front. GUTIERREZ stated he had absolute confidence in this individual and in the fact that he was completely anti-CASTRO in his sympathies. (u) *

[redacted] aka [redacted] a former member of the Cuban G-2 intelligence setup, who is in Madrid and who is cooperating with the Madrid Office at the present time. [redacted] who has advised that he sometimes has difficulty remembering names but never forgets a face, is believed to be in a position to furnish information on the subject if the latter were engaged in pro-CASTRO intelligence activities.
