1. MORNING 2 DECEMBER ODENVY REP FINALLY RECD GUIDANCE FROM ODENVY HQS WHICH ASKED HIM PROCEED ALONG LINES REF. MATTER DISCUSSED WITH AMB AND DCM AND CABLE TO DEPT VIA KUBARK CHANNELS BEING PREPARED WHEN **IN ANITION** ADVISED THAT INFO FROM LAUSANNE (PRESUMABLY FROM [redacted]) SHOWED THAT **GIBSON** PLANS LEAVE SUISSE 2 OR 3 DECEMBER AND TRAVEL TO FRANCE.

2. GIBSON ADDRESSES FRANCE AS FOLLOWS. OFFICE, PARIS BUREAU OF "REVOLUTION", PHONE ELYSEE 66-44. PRIVATE, 26 AVENUE SIMON BOLIVAR, APT 674, PARIS XIX.

3. DEFER TO HQS RE FURTHER ACTION RE GIBSON. WILL CONTINUE MONITOR **ANDERSSON** AND "REVOLUTION" IN CONNECTION WITH OUR LCHARVEST PROGRAM.
