1. AFTER CAREFUL CONSIDERATION HQ FEELS NO EFFORT SHOULD BE MADE BLOCK MOSBY ASSIGNMENT MOSCOW LEST OFFICIAL OR UNOFFICIAL KUBARK INTERFERENCE BE MISCONSTRUED.

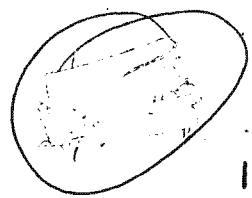
