SUBJECT : Senate Select Committee Request
(Roselli/Maheu/Giancana Matter)

1. Reference is made to a 22 August 1975 memorandum from the Review Staff (75-2597), which forwards a request from the Senate Select Committee for certain files and documents relating to the Roselli/Maheu/Giancana matter.

2. With respect to item number one of the referenced request, the pertinent Office of Security files concerning this matter have been assembled and are being maintained within the Office of Security. These files will be made available to designated Senate Select Committee staff members upon specific request, within the framework of established procedure for the Senate Select Committee's review of Office of Security files. It should be noted that no "personal or soft" files have been located within the Office of Security concerning this matter, other than those recently created in response to requests from the Rockefeller Commission or the Senate Select Committee.

3. On 25 August 1975, the Office of Security partially reviewed the files of the Inspector General's office with regard to this matter, in an attempt to locate any Office of Security documents dated during the 1960-1963 period which are not contained within Office of Security files. As a result of this review, four such memoranda were located. Copies of these four memoranda are attached hereto as exhibits, and a brief description of these documents follows:

a. Exhibit I: 4 April 1962 memorandum for the record captioned "The Attached Memorandum from the FBI - Subject: Arthur James Balletti, et al" concerning Colonel Sheffield Edwards' meetings with Mr. Sam Papich of the Federal Bureau of Investigation on 28 or 29 March 1962, and with another FBI representative on 7 February 1962.

b. Exhibit II: Federal Bureau of Investigation memorandum, dated 23 March 1962, and captioned "Arthur James Ballotti, et al. Unauthorized Publication or Use of Communications."

c. Exhibit III: 26 April 1962 memorandum for the then Director of Security from Mr. Lawrence R. Houston, General Counsel, concerning meetings which he had held with Assistant Attorney General Herbert J. Miller on 16 April 1962 and with Mr. Foley, also of the U. S. Attorney General's Office on 20 April 1962, concerning the Arthur James Balletti, et al case.

d. Exhibit IV: 14 May 1962 memorandum for the record, captioned "John Roselli," by Sheffield Edwards, which concerns an early April 1962 request from Mr. William Harvey for Colonel Edwards to arrange a meeting with John Roselli.

4. The chronological files of the former Director of Security, Colonel Sheffield Edwards, were reviewed for the years 1960 through 1964. Cited review of Colonel Edwards' chronological files disclosed only one document relating to the Roselli/Mahou/Giancana matter. This document is merely a copy of a memorandum attached hereto as Exhibit I, the original of which was located in the files of the Inspector General.

5. As stated, the pertinent Office of Security files regarding this matter have been assembled, and will be retained within this office pending their review by the Senate Select Committee Staff.
