1. TENTATIVE PLANS MADE FOR WIFE OF MARCOS DIAZ LANZ TRAVEL ON CUBANA FLIGHT MORNING 24 AUGUST FOR MEXICO CITY. SHE WILL TRAVEL UNDER HER MAIDEN NAME OF EMILIA ELVARA ALVAREZ Y MARTINEZ AND TWO DAUGHTERS WILL ACCOMPANY HER. HAVA WILL CONFIRM HER DEPARTURE.
