AMSWIRL-1

1. INTRODUCTION. In order to more precisely clarify your responsibilities for AMSWIRL-1 the below listed information is being forwarded in an attempt to clearly describe the nature and scope of the activities with which we believe AMSWIRL-1 should be associated. It is felt that a clear delineation of your responsibilities relative to AMSWIRL-1 as well as a restatement to AMSWIRL-1 of his mission on our behalf in the JKBAR area should minimize any possibilities that we might find ourselves embarrassed by AMSWIRL-1's present or future activities. The below listed charter for AMSWIRL-1 has been discussed by Andrew K. REUTERAN with IDEN A, Supervising ODBOOK Agent, Miami, IDEN B, District Director of GEORGE, and Kelvin W. SEBOLSON, Chief of Coa Locka. All of these gentlemen concurred heartily in this charter. This should insure that there will be a minimum amount of friction in the JKBAR area in the future between ODURGE, ODBOOK, AMSWIRL-1 and KURAEK.

2. SCOPE OF AMSWIRL-1'S ACTIVITIES. It is believed that the following items clearly define the nature and scope of AMSWIRL-1's activities in the JKBAR area on behalf of KURAEK. These activities are:

a. Collection of Priority Positive Intelligence. It is envisioned that AMSWIRL-1 will fulfill this responsibility by the timely debriefing of those refugees who enter PEPRINT via the JKBAR area. In this connection AMSWIRL-1 must understand that he cannot get access to these individuals until they are at least primarily processed by ODURGE. Once AMSWIRL-1 does gain access to a newly arrived refugee he is to skim off that perishable positive intelligence which may affect such items as the imminence of hostilities, the initiation of popular revolt or uprising, or

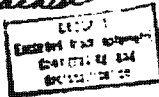

significant changes in PBRUMIN's governmental or military structure. This collection effort is designed solely to obtain priority perishable intelligence, and it is not designed to replace, duplicate or compete with CAC.

b. Spot Potential Sources Who May Have Viable Operational Leads. In the course of AKSWIRL-1's debriefing of refugees for priority positive intelligence he should also assess these individuals relative to any operational leads which they might possess. In this connection he is only to identify such leads and then report this information to JMWAVE by the most expeditious manner possible. This will insure that JMWAVE then has the opportunity to follow-up on these leads when the refugee in question arrives at CAC. Here again, it is important that AKSWIRL-1 understand that he is a primary flushing mechanism, and, as such, he is to identify individuals who warrant a more thorough debriefing either by CAC or by JMWAVE. Under no circumstances is AKSWIRL-1 to attempt to contact with or duplicate CAC's or JMWAVE's exploitation of the refugee flow in an attempt to find exploitable operational leads.

c. Quick Turn-Around Agent Candidates. As AKSWIRL-1 processes incoming refugees he should pay attention to fishing boat personnel in an attempt to determine whether some of these individuals can be recruited and turned around in a matter of hours prior to the time that their departure from PBRUMIN will be noticed. If such a quick turn around lead is identified AKSWIRL-1 should utilize JKBAR facilities for requesting assistance from JMWAVE to mount an operation with the prospective quick turn-around agent. If time does not permit JMWAVE's rendering such assistance then at the discretion of Chief of Base, JKBAR this lead can be followed up by JKBAR personnel as appropriate. In such a follow-up it is imperative that AKSWIRL-1 be cut out of the operation at as early a time as it is possible to achieve.

d. Counterintelligence Leads. AKSWIRL-1 is also charged with the responsibility of attempting to spot CI suspects from among those PBRUMINs who either enter PBRUMIN as refugees via the JKBAR area or who are already residents of the JKBAR area. It is clear, however, that AKSWIRL-1 only has a spotting responsibility with regard to this mission. Once a potential CI suspect is spotted no further action is to be taken on this matter by AKSWIRL-1 or JKBAR until such time as full coordination has been affected with JMWAVE. In most instances when this coordination has been affected the CI lead will be followed up by JMWAVE and/or JKBAR. AKSWIRL-1 will have fulfilled his responsibilities in the CI field at such time as he has brought the potential suspect to our attention.

e. Procurement of Documents, Weapons and Other Related Items. AKSWIRL-1 is also charged with the mission of procuring from incoming refugees selected categories of high priority documents, weapons and other related items. This procurement effort should, however, be kept to a minimum as too aggressive an effort in this field can complicate the refugee processing system at CAC. Specific guidance will be forwarded on a regular basis to JKBAR for passing to AKSWIRL-1 relative to the types of documents, weapons and other related items which should be obtained on a priority basis. In addition to this list it is assumed that both JKBAR and AKSWIRL-1 will exercise imagination, sound judgment and discretion in procuring other items which are of an obvious intelligence nature and which may appear in the JKBAR area on a target of opportunity basis.

3. SUPERVISION. AKSWIRL-1 is regarded as a JKBAR asset and the initial first echelon supervisory responsibility for AKSWIRL-1 clearly rests with JKBAR. In view of this it is believed

that Chief of Base, JEBAR should be in direct contact with the senior ODURGE representative in the JMBAR area. KUBARK requests to ODURGE in the JEBAR area should be handled by Chief of Base, JEBAR rather than by ANSWIEL-1. It is the intent of this dispatch to minimize the circumstances and occasions on which ANSWIEL-1 should be acting on behalf of KUBARK. The intent of the ANSWIEL-1 relationship is to utilize ODURGE cover for the accomplishment of a KUBARK operational support mission. This means that in those instances where ANSWIEL-1 surfaces his KUBARK relationship in order to accomplish his KUBARK mission he is seriously defeating the primary purpose of our having worked out this rather unique relationship with ODURGE. It would be appreciated if you would bear this factor in mind in all future dealings with ANSWIEL-1 and the ODYOKE agencies which are in the JEBAR area and who have an interest in the PBEURIN problem.
