SUBJECT LICHANT-1	

ACTION REQUIRED: See below

1. As the Station Case Officer no doubt realizes, three of the persons listed as close associates of Subject are leftists to some degree. While this may be advantageous since LICHANT-1 may be in a position to obtain better information for his studies for LIUFP and he may be more trusted by leftists in the target groups, Headquarters presumes the Station will exercise caution in directing Subject through the LIUFP's. LICHANT-1's PCA/OA is being amended to stipulate that the Station will not handle Subject directly, that he should not be made witting of KUBARK or ODYOKE interest in his activities, nor should sensitive requirements be revealed to him. This restriction can be waived upon assurances by the Station that LICHANT-1 does not share the pro-Communist and pro-Soviet, anti-U. S. sympathies of the three friends in question and that he can be adequately controlled.

2. Headquarters wishes to especially caution the Station regarding Jaime GARCIA Terres's who was reported in HPM-4426 of August 1959 as being in the pay of the Soviet Embassy for his literary work for the El Espectador magazine, and for his friendship with Maria Elena VAZQUEZ Gomez (MEXI 6486, October 1960) who is a suspect Soviet Agent.
