SOURCE AND APPRAISAL

FIELD REPORT NO. UFG-7351

A CUBAN REFUGEE WHO HAS MANY CONTACTS AMONG CUBAN EXILE ACTIVISTS. PREVIOUS REPORTING FROM THE SOURCE HAS PROVED TO BE FAIRLY RELIABLE.

1. NESTOR GONZALEZ OR GARCIA, WHO LEFT CUBA IN EARLY JUNE 65, PLANS TO RETURN TO CUBA ON WEEKEND OF 10-11 JULY OR THE EARLY PART OF THE FOLLOWING WEEK IN ORDER TO BOARD UP A CUBAN TRAIN. THIS OPERATION IS BEING FUNDED BY THE CUBAN REPRESENTATION IN EXILE (RECE). HE PLANS TO LEAVE MIAMI WITH LUIS SIERRA LOPEZ AND ONE OTHER PERSON IN A 25-FOOT BERTRAM EQUIPPED WITH A 210-HORSEPOWER INBOARD ENGINE AND PROCEED TO CAY SAL WHERE HE WILL DISEMBARK. AT CAY SAL NESTOR PLANS TO MEET SEVERAL BRITISH NEGROES WHO HAVE BEEN PAID TO HIDE HIM UNTIL HE IS PICKED UP BY A CUBAN FISHING BOAT. NESTOR WILL THEN PROCEED TO CUBA AND PLANS TO ENTER THROUGH HAVANA, THE SAME WAY THAT HE CAME

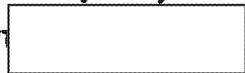

OUT. (FIELD COMMENT: LUIS SIERRA LOPEZ IS A CUBAN EXILE WHO WAS PREVIOUSLY INVOLVED WITH ROBERTO ELEJOS ARZU, ~~ST~~ GUATEMALAN MILLIONAIRE, WHOSE ATTEMPT TO OVERTHROW THE GUATEMALAN GOVERNMENT ASCORTED IN MAY 65. ANOTHER SOURCE WHO IS REGARDED AS RELIABLE REPORTED ON 1 JULY THAT SIERRA LOPEZ AND GUSTAVO FERNANDEZ RAVELO et al WERE PREPARING TO MAKE A TRIP TO CAY SAL TO MEET SOMEONE WHO WAS COMING OUT OF CUBA TO DISCUSS MONEY MATTERS WITH THEM. FERNANDEZ IS BELIEVED TO HAVE ACCESS TO A 24-FOOT BOAT EQUIPPED WITH ONE 225 HORSEPOWER INBOARD ENGINE AND TWIN 20-HORSEPOWER MERCURY OUTBOARDS. THIS CRAFT CARRIES FLORIDA REGISTRATION FL-6630-F AND ON 25 JUNE WAS SEEN AT THE PRIETO AUTO SERVICE, 732 NW 7TH AVE., MIAMI.)

2. NESTOR PLANS TO TAKE WITH HIM FOUR 9-MM SUBMACHINE GUNS WITH 950 ROUNDS OF AMMUNITION, FOUR ROLLS OF TIME FUSE, FOUR TIME DELAYS, AND 50 POUNDS OF PENTOLITE. WITH THE EXCEPTION OF THE PENTOLITE, ALL OF THE EQUIPMENT WAS PURCHASED CHEAPLY FROM THE CUBAN REVOLUTIONARY JUNTA (JUNTA REVOLCCIONARIA CUBANA, JURE). A FIFTH SUBMACHINE GUN, WHICH WAS INCLUDED IN THE PURCHASE, IT TO BE KEPT BY SIERRA LOPEZ.
