24 [redacted] ARRANGEMENTS FOR <sup>DALTON</sup> INTERROGATION INVOLVED BOTH [redacted] AND [redacted] BOTH OF WHOM COMMUNICATED WITH [redacted] CIA OFFICER

[redacted] ARRIVED AFTER DARK 23 SEPT. INTERROGATION DELAYED BECAUSE ARRANGEMENTS NOT WELL LAID ON. <sup>DALTON</sup> KEPT SOLITARY UNDER STREET-LEVEL IN CELL WITHOUT LIGHTS, SUFFERING STOMACH AILMENT. INTERROGATION TOOK PLACE IN LARGE "BULL PEN" WHICH WAS ONLY AVAILABLE SPACE

[redacted] OFFICIAL SILENTLY WANDERED IN AND OUT OCCASIONALLY DURING INTERVIEW.

2. <sup>DALTON</sup> DENIED INTEL TRAINING AND TRIED LEGALISTIC DEFENSE WHICH HE SOON ABANDONED WHEN CONFRONTED WITH EVIDENCE. THEN COWERED, SAYING HE INTERESTED ONLY IN CULTURAL MATTERS AND WRITING WHILE CUBA; KEPT REPEATING HE SORRY HE EVER BECAME INVOLVED ALL OF THIS AND WANTS ONLY GET OUT OF SALV, NEVER RETURN, NEVER AGAIN ENGAGE IN POLITICS. SAID LAST HEARD FROM MAURICIO DE LA SELVA ABOUT MONTH AGO AND ONLY ABOUT HER STUDIES AND INCONSEQUENTIAL ACTIVITIES. HE APPEARED HAVE NO KNOWLEDGE WHATSOEVER OF <sup>CUBAN DEFECTOR</sup> DEFECTION AND SEEMED STUNNED AT CONFRONTATION WITH SOME OF OWN BOSS AND <sup>CIA OFFICER</sup> KNOWLEDGE OF TRAINING

COMPANIONS BEING GIVEN OPPORTUNITY IN WHICH CASE THEY WOULD TELL ALL,

LEAVING HIM TO FACE CONSEQUENCES WITH NOTHING TO OFFER AND NO CHANCE

TO ESCAPE. DALTON [REDACTED] CIA OFFICER [REDACTED] I BEGGED [REDACTED] NOT TO QUESTION HIM AGAIN, WAS
