1. SUSPECT 1 REPORTED [redacted] WAS INVITED HIM FOR "INFORMAL CHAT" AT LOCAL CAFE EVENING 11 MARCH TO DISCUSS EXTENT INVOLVEMENT WITH AYLASH GROUP AND SPECIFICALLY WHETHER HE PASSED OPS FUNDS TO AYLASH 1.
