1. Paragraph 9 of this memorandum contains a recommendation for the approval of the DDCI.

2. Following are [REDACTED] Staff comments and recommendations on subject and reference which is attached hereto. G

3. Both the Office of Security and the Technical Services Division have had a sustained interest in the subject of hypnosis and have subsidized research in it. Both offices and the [REDACTED] Staff have been alert to developments which might be of operational use. But, so far, nothing demonstrably useful in operational situations has been found. In June 1960 the [REDACTED] Staff, in cooperation with the Office of Security and TSD, initiated a program to attempt testing of hypnosis in operational situations. The emphasis for this purpose has been on relatively little used rapid induction techniques. We believe this type of hypnosis, rather than the classic type which most practitioners have in mind, probably offers the greatest possibilities for operations, and we are on the alert for opportunities for field testing. G

4. To date only one operational test has been conducted; it was inconclusive. Difficulties in operational testing revolve around three points: (1) the problem of finding operators for training who have the necessary operational talents, language ability, and motivation; (2) the extreme difficulty of finding experimental subjects and situations which do not have a dangerous potential for Agency

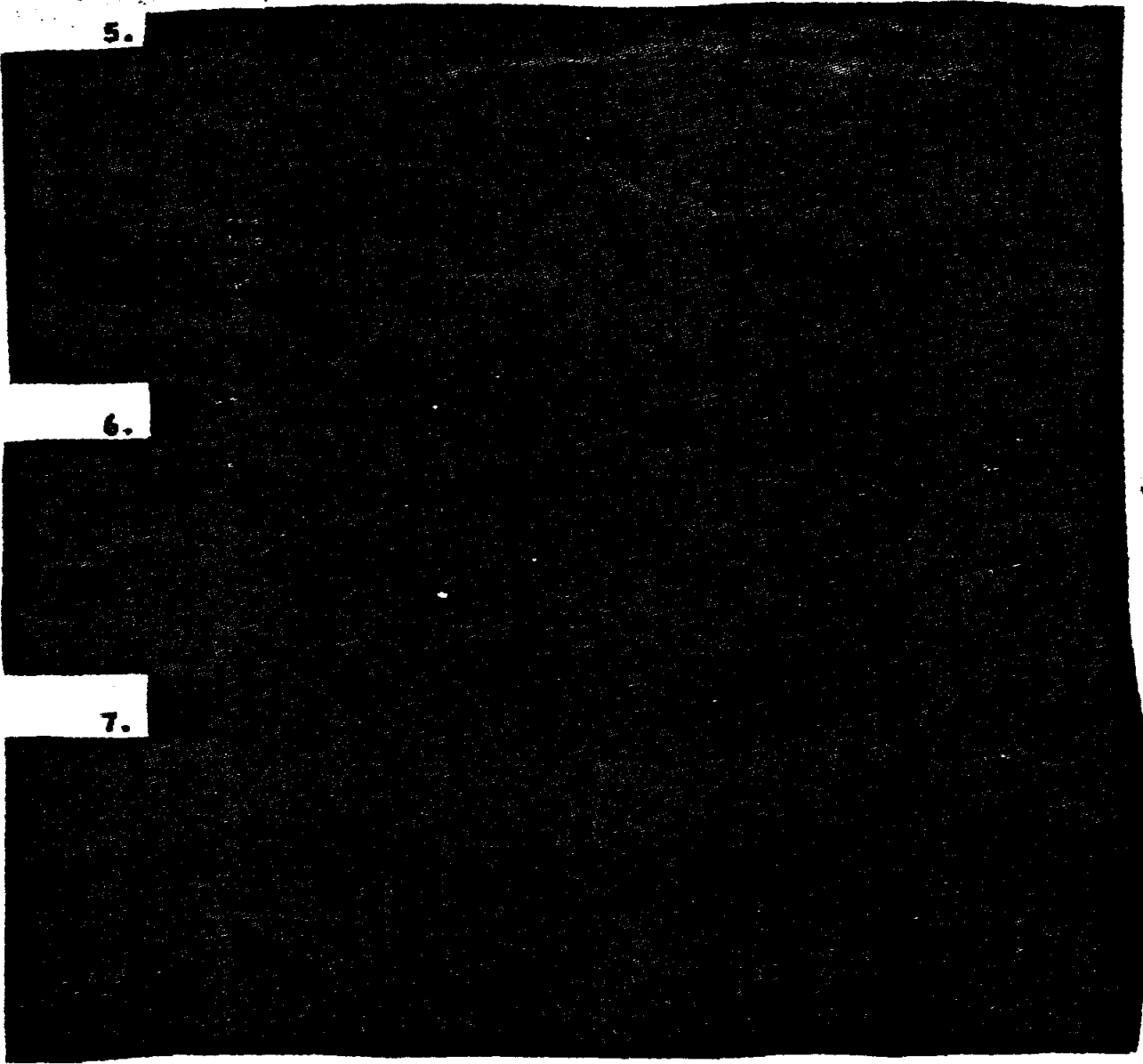

9. It is recommended that Mr. [redacted] be told the following:

Although CIA does monitor developments in the field of hypnosis for both defensive and offensive reasons, we feel that basic research in this field should remain in the hands of private institutions and overt elements of the Government.

His interest and offer are appreciated, and the possibility of utilizing his assistance will be explored.

*F/I* We are au courant on the operational possibilities of most [redacted], but we appreciate his interest.

It would be unwise to advise Mr. [redacted] of the sensitivity of the subject and it is recommended that the Agency reply not be in writing.

10. The gist of the above recommendation was conveyed by telephone to Mr. [redacted] by Mr. [redacted] of this staff on 22 November.
