MEMORANDUM FOR THE RECORD

SUBJECT: Project MKULTRA, Subproject 11

1. The scope of this research program is the investigation of the seeds of the plants *Abrus precatorium* and *Sem. Rhynchosiae phaseoloidis* D. C. by chemical and biological means for the purpose of obtaining in pure form the active constituents thereof.

2. A primary goal in the case of the *Abrus* seeds is the preparation of a supply of the exceedingly toxic protein, abrin, which falls into the same class of substances as ricin and botulinus toxin.

3. [REDACTED] B & C
[REDACTED] has agreed, in the attached letters, to undertake this work for the Agency.

4. The total cost of this project will not exceed \$11,000.00 for a period of one year ending 1 August 1954.

This is with reference to our recent discussions concerning the examination of two botanical materials which are of interest to you.

We would be willing to examine these materials for you in order to determine chemical characteristics and pharmacological and physiological effects of the active materials contained in them. Our usual practice in such cases is to charge for such studies on the basis of our own accounting, plus 10%. If such a procedure is acceptable to you, we would propose entering into an agreement which would limit our accounted expenditures to \$10,000 for a period of one year.

When work has progressed to the point where a charge of \$10,000 is approached, we would consider extending the agreement based on the facts available at the time. You may proceed to draw up an agreement on this general basis if you feel that such a procedure is acceptable to you.

So far I have not discussed this matter with any of our staff members pending advice from you concerning the approach which would be permissible.





I have discussed the possibility of an open-end contract with [redacted] and he has agreed that we would be willing to undertake studies up a billing of \$10,000 in a year. This could, of course, be modified under the terms we discussed when we approach the limitation on funds.

I have not discussed this project with any of my responsible people in the laboratory since I have been awaiting word from you on the approach that is permissible. If we are free to discuss our problems in the terms proposed in our last meeting, I can proceed with a little more certain plan.

I have also drawn from our file the list which I mentioned to you. My recollection was faulty, since the materials were not identified in any way. Only the applications were given, and for identity it would be necessary to go to the original source of the information. The listing was offered to us for an indication of our interest in the applications described.






