This is the final response to your Freedom of Information Act (FOIA) request of 18 June 2014, which was received by this office on 19 June 2014, for "a copy of all records pertaining to the policy of your agency on Consensual Monitoring." As noted in our interim response of 30 March 2016, your request was assigned Case Number 78303, and there are no assessable fees for this request. A copy of your request is enclosed.

As also noted in our interim response, there were additional documents responsive to your request that were placed into our queue for review. We have now processed those materials under the FOIA, and the documents you requested are enclosed. Certain information, however, has been deleted from the enclosures.

Some of the information deleted from the documents was found to be currently and properly classified in accordance with Executive Order 13526. This information meets the criteria for classification as set forth in Subparagraph (g) of Section 1.4 and remains classified SECRET as provided in Section 1.2 of the Executive Order. The information is classified at this level because its disclosure could reasonably be expected to cause serious damage to the national security.

In addition, this Agency is authorized by various statutes to protect certain information concerning its activities. We have determined that such information exists in these documents. Accordingly, those portions are exempt from disclosure pursuant to the third exemption of the FOIA, which provides for the withholding of information specifically protected from disclosure by statute. The specific statute applicable in this case is Section 6, Public Law 86-36 (50 U.S. Code 3605).

Since information was withheld from the enclosures, you may construe this as a partial denial of your request. You are hereby advised of this Agency's appeal procedures:

You may appeal this decision. If you decide to appeal, you should do so in the manner outlined below.


