Unknown Subject: Threat Against Senator Edward F. Kennedy

On July 14, 1968, a man identifying himself as [redacted] telephonically contacted the New York Office of the Federal Bureau of Investigation (FBI), and advised that he had been drinking in the American Legion Post Bar, 49th Street near Eighth Avenue, New York, New York, on the morning of July 14, 1968, with a man whom he identified as a German Irishman named (First Name Unknown) [redacted] Kalley became very boisterous and stated "we are going to get Ted Kennedy". The bartender tried to keep [redacted] quiet; however, [redacted] bought him several drinks more. [redacted] attempted to obtain more details, but was unable to do so.

The information furnished herewith concerns an individual who is believed to be covered by the agreement between the FBI and Secret Service concerning Presidential protection, and to fall within the category or categories checked.

1.  Has attempted or threatened bodily harm to any government official or employee, including foreign government officials residing in or planning an imminent visit to the U. S., because of his official status.
2.  Has attempted or threatened to redress a grievance against any public official by other than legal means.
3.  Because of background is potentially dangerous; or has been identified as member or participant in communist movement; or has been under active investigation as member of other group or organization inimical to U. S.
4.  U. S. citizens or residents who defect from the U. S. to countries in the Soviet or Chinese Communist blocs and return.
5.  Subversives, ultrarightists, racists and fascists who meet one or more of the following criteria:
  - (a)  Evidence of emotional instability (including unstable residence and employment record) or irrational or suicidal behavior.
  - (b)  Expressions of strong or violent anti-U. S. sentiment;
  - (c)  Prior acts (including arrests or convictions) or conduct or statements indicating a propensity for violence and antipathy toward good order and government.
6.  Individuals involved in illegal bombing or illegal bomb-making.

On August 21, 1968, Deputy Sheriff [Redacted] Jailer, Clark County Sheriff's Office, Springfield, Ohio, advised a Special Agent of the FBI that [Redacted] [Redacted] had been arrested on August 7, 1968, by Springfield, Ohio police on charges of disorderly conduct, gambling, petty larceny, grand larceny, and probation violation, and was released to the Ohio Youth Commission, school for boys, Lancaster, Ohio, on August 15, 1968.

Deputy Sheriff [Redacted] advised that while confined in Clark County Jail, [Redacted] had evidenced definite mental disturbance manifestations. In addition, [Redacted] had written on his cell wall "1 more Kennedy to Go". Deputy Sheriff [Redacted] advised he had asked [Redacted] what he had meant by this and [Redacted] refused to comment.

Foods Magazine, 1776 Broadway, New York City.

[redacted] stated he had lost one leg in the recent  
past and suffers from severe pains in his shoulders. To over-  
come the pains he is in the habit of drinking heavily, and  
often times while drinking, he worries about his personal  
problems as well as national and international problems. He  
said that when in this frame of mind, he frequently calls or  
writes the Federal Bureau of Investigation (FBI) and other  
agencies presenting his thoughts regarding the particular  
problem bothering him at that time.

According to [redacted], he has written the FBI on  
two occasions warning of leaks in that organization. [redacted]  
was pressed for any information which would indicate to him there  
was such a leak. He said that on one occasion an individual  
made a comment to him to the effect that "Some people in the  
neighborhood don't want any feds around." He said that this  
statement was made subsequent to a phone call he had made to  
the New York Office (NYO) of the FBI in which he reported a  
conversation he had overheard in a bar room. He explained that  
after giving thought to the above, in his opinion, it did not  
constitute a leak and was no more than a coincidence.

[redacted] continued that about eight months ago he wrote a letter to the New York Office, FBI denying a local rumor that he had sold out to the mob. He said that sometime after that he overheard a conversation relating to the contents of his letter to the FBI. [redacted] was questioned as to the details of the conversation he overheard at which time he admitted the letter to the FBI was not mentioned in the conversation, however, the rumor that he had sold out to the mob was discussed. [redacted] continued that his previous statement that there were leaks in the FBI were not supported by facts and he possessed no specific information of any such leaks.

[redacted] was questioned if he had any information of a threat against Senator Edward Kennedy at which time he furnished the following information:

While at the Stanley Erickson American Legion Post, Brooklyn, New York, he met an individual by the name of First Name Unknown (FNU) [redacted] who was not a member of the post. He explained that he had met [redacted] at the post on a Sunday morning at which time the post is open to the general public. [redacted] stated that he had been drinking heavily and apparently [redacted] also had been drinking a great deal. During the conversation which covered many topics, [redacted] made the remark, "We're out to get Ted Kennedy now. He and his family are traitors to the country," [redacted] volunteered that the above statement was made in jest and while both were under the influence of alcohol. He said that he had not seen [redacted] since the same meeting with him on the above occasion.

According to [redacted] he enjoyed writing and calling the FBI as he had always been treated very considerately and courteously on each occasion. He said that he had frequently called the NYO while under the influence of alcohol.

[redacted] was asked if he had any additional information which would be of value to the FBI and he stated that he did not. He mentioned that he would like to work with the FBI in an undercover assignment and it was explained to him that there was no need of his assistance at this time.

Mr. [redacted] advised that at 11:18 and 35 seconds p.m. in that show technical difficulties at the television station had produced brief static and an audio override of some of the sound from a tape recording which was being prepared for the show entitled "Garrison's Guerrillas" for showing on September 3, 1968. [redacted] explained that because of this difficulty the words "assassination of Hitler" were heard on the audio portion of "Three Dangerous People." 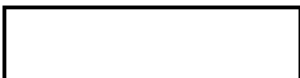

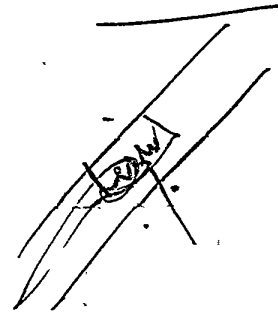

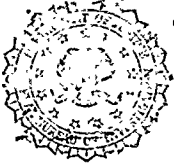

Mr. [redacted], Inter-Divisional Information Unit, Department of Justice, Extension 2364, called at 10:10 a. m., 1-18-69, to inquire if we knew whether there is a [redacted], or whether we were making any inquiries in this regard. Burns was told our only information in this matter came from the Public Information Office of the Department; that we had no information of the existence of such a person and that we were making no inquiries as there is no Federal violation in our jurisdiction. In addition, he was told that Secret Service and other appropriate local agencies had been alerted to this threat. Since [redacted], is an extremely common name and there is inadequate background and description available, it was not possible to make a meaningful check of Bureau files as there are hundreds of references on persons with the same name.

UPI release 1/18/69, indicated Fairfax County Virginia Police at the request of the FBI, had ordered a patrol car to remain in the immediate area of Kennedy's McLean, Virginia home "until further notice."

Our Richmond Office was not involved in this matter and attached indicates WFO upon inquiry by Fairfax Police Department merely related facts of the threat and gave no instructions whatsoever as to how local authorities should handle same.

At approximately 9:30 p.m., on 1/17/69, Night Supervisor JOHN F. BURNS, WFO, received a telephone call from Desk Lieutenant [Redacted] of the Fairfax County Police Department. [Redacted] advised he had received a telephone call from the Metropolitan Police Department (MPD), Washington, D. C., concerning above-captioned matter, and that Captain [Redacted] (ph) wished to speak to SA BURNS about it. SA BURNS explained to [Redacted] that the FBI was in receipt of information concerning a threat against Senator EDWARD M. KENNEDY, and that he was in the process of notifying appropriate agencies. It was pointed out to [Redacted] that the FBI had no jurisdiction in this matter except to notify appropriate agencies.

SA BURNS explained to [Redacted] the details of the threat, and further that the subject was known to the U. S. Secret Service as having made threats of this nature previously, which threats were unfounded.



[Redacted] Vienna, Virginia, age [Redacted] advised a Special Agent of the Federal Bureau of Investigation that he is a student at The George C. Marshall High School, Falls Church, Virginia. He said he is employed part time as a bus boy for the Evans Farm Inn, 1696 Chain Bridge Road, McLean, Virginia.

He acknowledged telephonically reporting having overheard another bus boy state he had sent 50 letters to Senator Edward Kennedy and that if he were caught he (the other bus boy) could "get life," and that because of this statement he assumed the letters were of a threatening nature.

[Redacted] advised that he actually did not overhear such a conversation. He said that on February 9, 1969, as he approached the kitchen table where employees eat at the Evans Farm Inn, he overheard a word or two of a conversation between two other bus boys in which Senator Kennedy's name was mentioned. He said he endeavored to join in the conversation but does not get along well with other bus boys and they left the table.

He later complained at home about the other bus boys being anti-social. To support this complaint, he made up the story of having heard the boy say he had sent 50 letters to Senator Kennedy and the assumption they were of a threatening nature, which he told his father. His father insisted that he call the FBI, which he did.

He said he wanted to retract his telephone conversation and apologized for having caused trouble. He advised he now realized the serious nature of his falsehood but had not considered the possible consequences. He said he had admitted this to his father. He said he has not worked at Evans Farm Inn since February 9, 1969.

The following information was received at the Los Angeles Division of the FBI on May 5, 1969:

On May 4, 1969, at approximately 7:30 p.m., a call was received at the Detective Division, Watch Commander's Desk, Los Angeles County Sheriff's Office (LASO), from a [Redacted]. [Redacted] is a telephone exchange operator who handles calls for Doctor [Redacted]. Doctor [Redacted] is a psychiatrist who testified for the prosecution in the Sirhan Sirhan trial.

[Redacted] stated that a caller who identified himself as [Redacted], and who furnished his telephone number as [Redacted], said that he was at the Beverly Hilton Hotel, and that he wished to contact Doctor [Redacted]. [Redacted] stated he had information regarding another "Arab" from Sirhan's group who was planning to kill Senator Ted Kennedy.

It was determined by the LASO that telephone number [Redacted] is listed to [Redacted] [Redacted] Los Angeles, California.

Representatives of the LASO attempted to contact [Redacted] at [Redacted] in Los Angeles with negative results on May 4, 1969.

[Redacted] was later paged at the Beverly Hilton Hotel, and an individual responded to this page by identifying himself as [Redacted]. [Redacted] told representatives of the LASO that he used the name of [Redacted] to keep from being

killed by the Arabs. [redacted] then went into great detail telling of his grief over the assassination of Robert Kennedy and of his great concern for Ted Kennedy. He felt that the Arab nation was conspiring to kill Ted Kennedy. He could, however, furnish no names of any conspirators. He furnished two telephone numbers, [redacted] and [redacted], which he said he had obtained from people of the "Arab race" whom he had met in restaurants. [redacted] main concern appeared to be that if Senator Kennedy came to Los Angeles, that he [redacted] be allowed to stand in front of the Senator to disarm any person who might pull a gun, and if unable to do this, to stop a bullet with his body. [redacted] said he had attempted to work with the FBI and Secret Service, but that "they" were not willing.

After discussing this entire matter with [redacted] the Sheriff's Office representatives concluded that [redacted] had no information of value to furnish.

It is noted that [redacted] has contacted the Los Angeles Office of the FBI on numerous occasions during the period 1961 through the present. In December 1962, he was described by Sergeant [redacted] Administrative Vice, Los Angeles Police Department, as a "nut" and a chronic nuisance.

Dear Sir:

The information furnished herewith concerns an individual who is believed to be covered by the agreement between the FBI and Secret Service concerning Presidential protection, and to fall within the category or categories checked.

- 1.  Has attempted or threatened bodily harm to any government official or employee, including foreign government officials residing in or planning an imminent visit to the U. S., because of his official status.
- 2.  Has attempted or threatened to redress a grievance against any public official by other than legal means.
- 3.  Because of background is potentially dangerous; or has been identified as member or participant in communist movement; or has been under active investigation as member of other group or organization inimical to U. S.
- 4.  U. S. citizens or residents who defect from the U. S. to countries in the Soviet or Chinese Communist blocs and return.
- 5.  Subversives, ultrarightists, racists and fascists who meet one or more of the following criteria:
  - (a)  Evidence of emotional instability (including unstable residence and employment record) or irrational or suicidal behavior;
  - (b)  Expressions of strong or violent anti-U. S. sentiment;
  - (c)  Prior acts (including arrests or convictions) or conduct or statements indicating a propensity for violence and antipathy toward good order and government.
- 6.  Individuals involved in illegal bombing or illegal bomb-making.

Enclosed are Xerox and true copies of three communications mailed to the victims by the subject. A copy of the envelopes are also enclosed.

The communications contain threats to the victims as well as the President. They were made available by U. S. Secret Service who advised that that agency is conducting investigation.

Inasmuch as the letters contain threats to the victims, Indianapolis discuss the matter with the appropriate U. S. Attorney concerning a possible violation of the Federal Extortion Statute. Indianapolis and WFO advise appropriate local authorities concerning these threats. Submit results in form suitable for dissemination by 5/12/69.

The original communications are apparently in the custody of U. S. Secret Service and copies furnished are being examined in the Laboratory. You will be advised of the results.

Subject was convicted for a violation of the Bank Robbery Statute and was sentenced on 2/17/69 to 10 years in Federal custody. The conviction was in the case entitled Roy James Huck, Et Al.; Bank of Greenfield, 4200 South 76th Street, Greenfield, Wisconsin, 7/26/67, CC: Milwaukee."

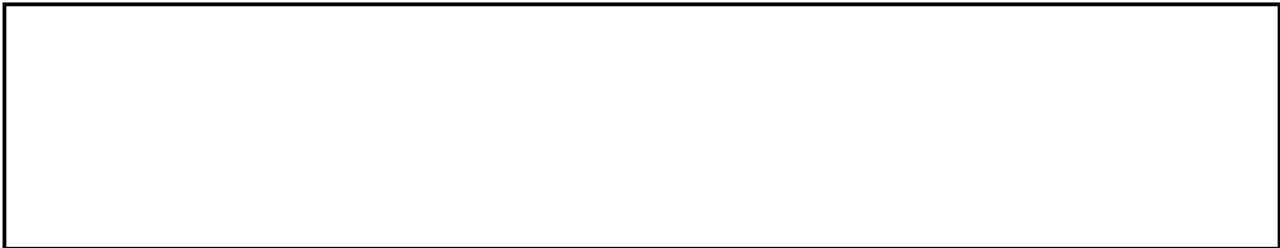

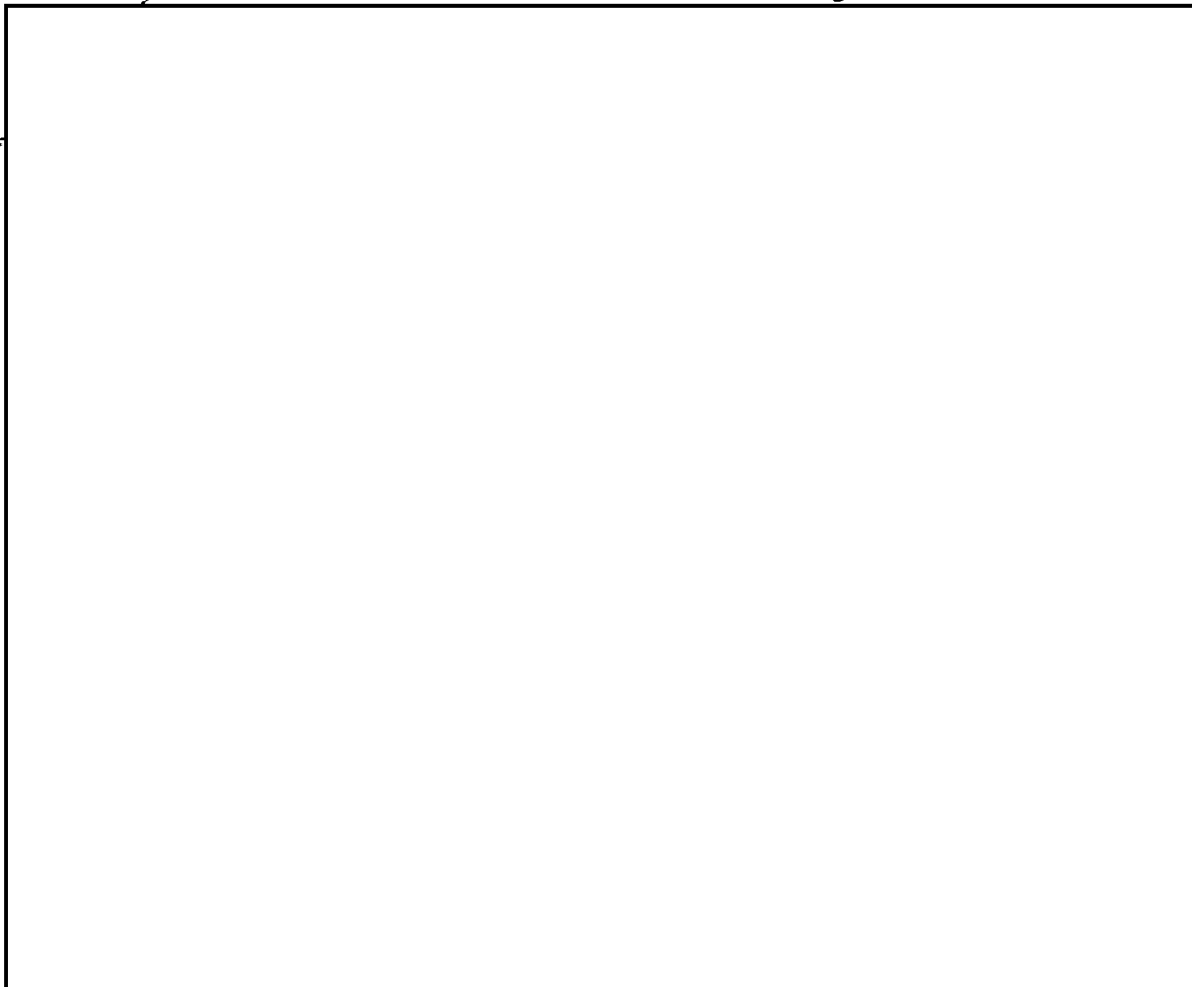
