Dear Mr. Greenewald:

This is our Agency's final response to your electronic Freedom of Information Act request dated August 11, 2014. Your request sought records concerning to a list of VIP visitors to Guantanamo Bay Detention Camp, including Camp Delta, Camp Echo, and the closed Camp X-ray during the time frame of January 2002 through the present. Please note that per our correspondence on 19 November 2014, you amended your request for all documents between January 2002 through September of 2013.

The search for information responsive returned the enclosed information consisting of approximately 150 pages (Bates 000362-000511). The review of this information determined that portions of information are partially released pursuant to 5 U.S.C. § (b)(1), 5 U.S.C. § (b)(3), the applicable statute 10 U.S.C. § 130(b) and 5 U.S.C. § 522 (b)(6).

a. Exemption 1, portions of information are properly classified in accordance with Executive Order 13526, Section 1.4 (c), which pertains to intelligence activities, intelligence sources or methods. Release of such information is not permitted under 5. U.S.C. § (b)(1);

b. Exemption 3, 5 U.S.C. § 552(b)(3), pertains to information exempted from release by statute, in this instance the pertinent statute is 10 U.S.C. § 130b, which protects personnel assigned overseas, or assigned in sensitive or routinely deployable units;


c. Exemption 6, 5 U.S.C. § 552(b)(6), permits withholding of personal information of individuals contained in personal, medical and other files that, if disclosed to requester, other than the person about whom the information is about, would reasonably be expected to constitute a clearly unwarranted invasion of the privacy of individuals.

Please note that the enclosed responsive records are part of a litigated FOIA by another requester; therefore, your rights to appeal are mooted.

With this action, I am administratively closing this file in our office. There are no
