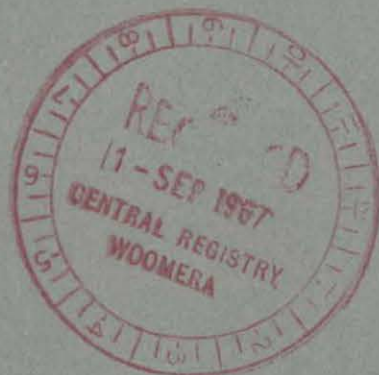

Please accept my warmest thanks ^{your letter &} for your short term loan of the above ^{Number} ~~volume~~ which is returned herewith. The local primary school was staggered!

I am also ashamed ~~at~~ that 5 months before the first specimen ever ~~found~~ of the pygmy possum "Burrhamys Parvus" was found at the University of

Club Lodge at Mt. Rotham, I, late at night picked up a strange pygmy possum not far from Mt. St. Bernard (on the way to U.S.C.) and made no location notes ~~at~~ on capture! — I took the specimen on with me to U.S.C. and released same because I had no time to build a proper cage & make other arrangements for its transmission to Melbourne! It is now incumbent on me to "pull up my socks" & go back & get ~~another~~ a duplicate specimen, as I feel sure the solitary specimen picked up at U.S.C. in June was the one released by me in January.

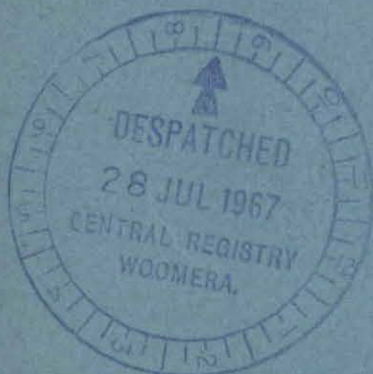

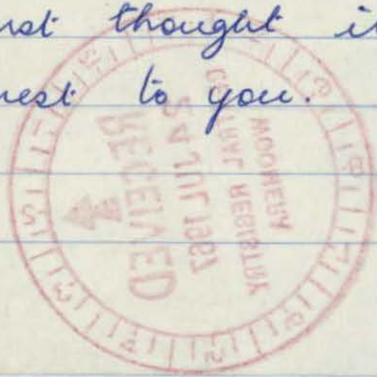
Dear Sir,

IDENTIFICATION OF SPACE VEHICLE FRAGMENTS.

Reference is made to your D.5492/1/1 dated 16th August, 1962; it is advised that information has been received from a lady residing in the extreme south of York Peninsular who witnessed what could well have been space vehicle fragments on re-entry. Hereunder are relevant extracts from her report.

" About 5.30pm I was returning home from football with my two girls then 11 and 6 years when about 20 yards from our garage I leaned forward to change gears and became aware of something falling from high up in the sky. It was dusk with a glow about the western and southern horizons.

My first impression was that it looked like a large falling meteor, it seemed to be wreathed in a smoky haze this made it look roundish there was some part of it alight though I could see no flames, the part alight seemed to be central. The direction of its fall seemed to be SW to NE: but more west than south. It was not falling straight down but at an angle a sharp angle (see illustration) I could not pick out any definite shape because of the smoky haze except that it appeared like a round boulder encased in smoke. The smoke seemed to be going outwards and backwards over it as it descended.

The diffused light was still there. I stopped the car, switched off the dim lights, told the children to wind up the windows and lie on the floor of the car and I knelt down beside them, and saw that "it" was much lower in the sky, it now was fully alight, with great tongues of flame pouring from the front part to the rear to encompass the whole thing, it now resembled in shape what I should imagine a wingless plane would look like. The sheets of flame were pulled backwards and appeared to be six to eight ft in length there was no trail at all apparent - no separating parts - it seemed to be all intact but well alight. The angle was not as acute the object appeared to be settling more into an arc, more west to east than SW to NE. The arc was slight more

Quickly the flames changed so that the object looked like a fiery hot ingot which gradually went black from the front portion to the rear. I can remember the final glow as it was dying out then all was black and I saw nothing for about two seconds. It wasn't very far from ground level now as I leaned against the windscreen ready at the last second to throw myself over the children in case of accident. And then I had my first clear and distinct picture of the shape and outline of what looked like a rocket, it was much smaller than I anticipated probably 3 ft in length it was pointed directly to the east from the west flying parallel to the ground about 20 ft above the ground the front end was shaped like a cone and the rest like a cylinder. The arc had gone it was definitely going parallel to the ground. It was black as it was outlined against the slight glow from the south. It was moving smoothly but not at excessive speed with the cone pointed into the east. It disappeared from my view behind the pine tree (see illustration). I now had to look into the east it was quite dark, a small grove of trees extended beyond the pine tree, I saw nothing more no explosion no brightness or noise. The windows of the car were up. After about a minute I put down the window and looked and listened intently I saw or heard nothing above the slight movement of leaves in the trees and the noise of the sea about $\frac{1}{4}$ mile south.

Next morning I thoroughly searched on area directly east of the house. Just beyond the grove of trees the ground is fairly stoney, with rock heaps and sheet rock. I looked for twisted wreckage at first then I noticed very minute black pieces as tho something had shattered, these were spread around fairly scattered. These bits were black they resembled burnt paper but seemed to have more density than I imagined burnt paper would have. I continued searching in widening circles and eventually found in a ploughed up paddock due south of the scattered black pieces about 250 yds away - a small heap of blackened material. The paddock had been ploughed up the week previous so the material was undisturbed it rested in the furrows not particularly imbedded if at all. It resembled in appearances what loosely rolled burnt paper would look like the denser. It was about 12 to 15 ins high by 18 inches in length. It was very black, I could see no printing as is usual with burnt newspapers etc. Not caring to risk radio activity I found a stick and prodded it, it broke up but not as lightly as paper would.

I enquired from my husband but definitely he had not burnt anything there or further up where the black bits were. The paddock was later put into crop, so nothing remains that I know of, tho at times I have kept my eyes open when out in the paddocks beyond this area, but have found nothing else.

I think I have it all down and can add nothing further except that I thought that although the rocket was falling it did not seem to be entirely out of control, at no time did it jerk about, or separate, and from the first sighting to its disappearance behind the tree would probably be about fifteen seconds to twenty seconds certainly not less probably about twenty seconds.

After reading this through I find I havent mentioned anything about sound. Remember the windows were up, but I was aware of a rushing sound when the ? rocket was encased in flames but this might have been my imagination, I remember I was impressed by the smoothness and lessened speed of the blackened rocket as it glided parallel to the ground never wavering from the east, directly in its path were three tall gums with long branches there were gaps of course, it was only about 15 ft away that I found the tiny black particles mentioned before. Incidentally if it had not been for these trees it might have gone much further as our house and surrounding are on a rise and beyond this the ground level slopes away to St. Vincents Gulf. "

2. Since the incident happened some time ago the actual date is in doubt. The authoress mentions "three years ago on a Saturday". In a further statement "the day after the first two American Astronauts made their flight" - it is understood that this was Wednesday 23rd March, 1965. Again she mentions at dusk between 5.30pm and 6.00pm - this does not agree with the last date.

4. The lady in question has been assured that there will be no publicity associated with the incident.

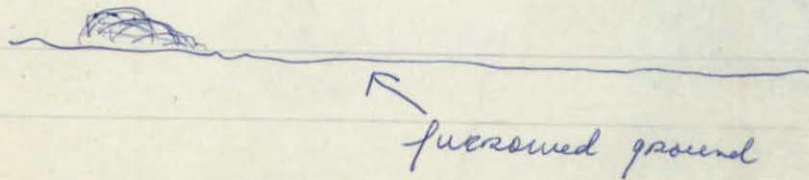

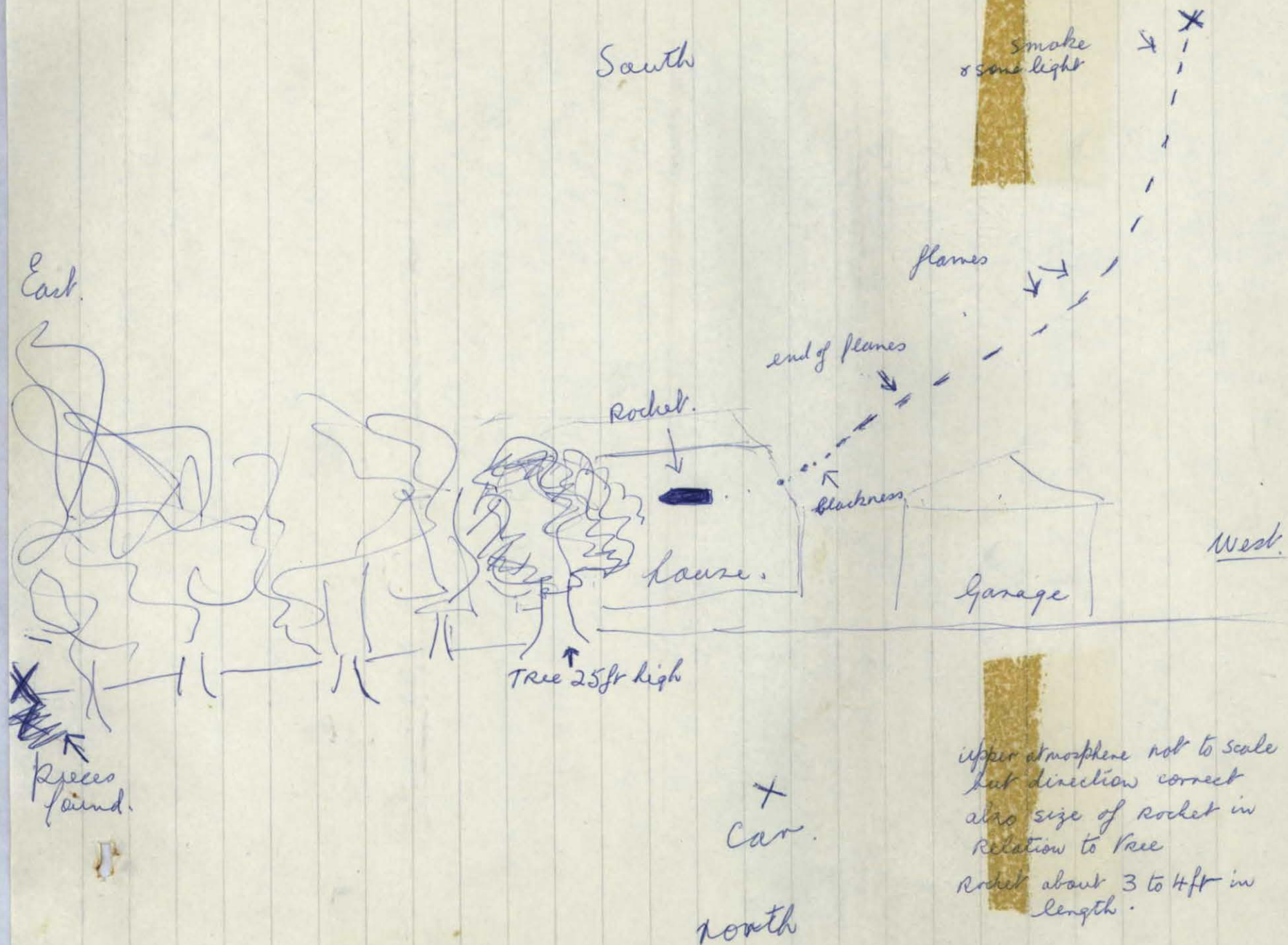

Several weeks ago I noticed an item in a periodical which concerned rocket experiments carried out three years ago these were secret. It has cleared up a mystery for me as one of these came down to less than twenty yards in front of myself and two daughters. I watched it from high up in the sky until its final stages. There were no damages to life or property, and we had the comparative safety of a car to protect us from flying bits & pieces.

At the time I thought the rocket had something to do with the space craft that had conveyed the first two ^{American} astronauts in space but it had confused me because these two astronauts had been picked up in the sea (capsule) the day before; You will be able to pinpoint the date with the previous information also it was a Saturday and the time between 5-30 and 6 pm.

I did not report the above occurrence to anyone (except my husband later) as the thought of publicity & the possibility of being thought a crank stopped me. I read the papers thoroughly for weeks but found no report or mention any where. If I had known about the rocket experiments I would have contacted

S/O E.S.O. - I've deal with this 7/17

Woomera as soon as was possible.

If some one in authority would write, I could put down in words, exactly that which I witnessed as the impressions are still very vivid, even to the shape of the burnt out rocket in its latter stages.

I don't believe anyone else apart from myself & two daughters saw this rocket in this locality. I have never heard anyone mention it, but this is understandable as our farm is out of town and our nearest neighbours are a few miles distant, and the other sides are St Vincent Gulf & Investigator Strait. Please no publicity to newspapers. I only wish to give information for the records.







2. Every effort has been made to identify the aircraft sighted by Squadron Leader JOHNSTON without success. In addition to the enquiries made by the R.A.A.F. both the Range Overseer and the writer telephoned a number of pastoral properties within the area; the State Police carried out, through their representatives, enquiries at Andamooka, and checks were made through Maralinga all with nil result.
3. It is a pity that so much time was lost before it was determined that the aircraft was alien to Woomera and it is disturbing to learn, notwithstanding modern aids and facilities, that it is not possible to identify it.
4. Because of good weather (light winds and smooth seas) and the large movement of light aircraft taking part in the Air Pageant at Parafield and Edinburgh together with the reported absence (see Gibber Gabber of 8/9/66) of a number of aircrew personnel and aircraft from Woomera the possibility, slight though it may be, of unknown foreign shipping in the Great Australian Bight taking advantage of the situation and launching an aircraft can not be Overlooked.
5. As discussed with you the possibility of using Range instrumentation in tracking such incidents in future will be explored. Because of the altitude (300 to 400 feet) in the present case it is not thought that these measures would have been successful. The holding of a Meteor on standby for scramble in such cases would most likely be unrealistic but could be examined.

1. Enclosed herewith is a report made by Squadron Leader J.H. JOHNSTON.
2. Air Traffic Control received the substance of this report at 1119 hours and initially simply stated that no Otter aircraft was flying. It proved difficult to get further information as Squadron Leader J.H. JOHNSTON was actively engaged as Pilot on the trial.
3. At approximately 1145 a full report was received, but it was then too late to investigate from the air.
4. Widespread checks were carried out through Adelaide, Ceduna, Whyalla, Port Augusta and Leigh Creek, but no relevant information was secured. Identification was complicated by the large number of light aircraft converging on ADELAIDE for the Air Show.
5. It is now considered that the only possible means of identifying this aircraft will be if Security can locate some other person at Koolymilka, Rangehead or nearby station who can give a more precise description.
6. This letter and report confirms telephone messages passed from Flight Lieutenant WHITE to the Superintendent and the Establishment Security Officer on Friday, 9th September 1966.



1. At approximately 1117 hours on 9th September 1966, I was in the Pilot's Control Tower for runway 12 on the northwest approach to EVETTS FIELD. A Jindivik Crew Training Sortie was in progress.
2. On completion of the third overshoot I swung the binoculars around to establish contact with the Jindivik which was south of EVETTS at that time.
3. While searching for the Jindivik I observed what appeared to be an aircraft of the high wing monoplane type, substantially white in colour with some red or orange markings, flying at an estimated height of 3-400 feet above ground level. The aircraft was sufficiently low to have its image distorted by heat haze which is always magnified when viewed through binoculars.
4. The aircraft appeared to be about 4-6 miles range, approximately south-south-west of the field and was travelling approximately north west at the time of sighting.
5. Because of the construction, colour and speed, I immediately assumed the aircraft to be a No 1 Air Trials Unit Otter and reported the aircraft as such.
6. I did not track this aircraft for more than ten seconds as the Jindivik required my attention. Three or four minutes later I again looked for this aircraft without success.
7. Flying Officer LERAY-MEYER was with me during this incident and he confirms the details of this statement.




I must apologise for not acknowledging your letter sooner, but let me assure you I was not "sucking eggs".



As a result of your letter of 11th October, I have made some enquiries in an attempt to identify the object which you sighted. It certainly was not one of our rockets, and is unlikely to have been a meteorite if your father had time to waken you and your mother; meteorites move very fast and are not usually visible for more than a second or two.

In the past, reported objects of this nature have been found to be navigational lights of a very high-flying aircraft, or else an Earth satellite. Our Space Research Station advises that in early August the orbit of the American satellite Saturn 5 would take it over your latitude in the early morning at a height of 420 miles and it is like a very bright star when it is illuminated by the sun. It is usually white but if your atmosphere were very dusty, that could account for a reddish colour. It would take 3 or 4 minutes to go across the sky.

I am sorry that we cannot make a positive identification for you, but trust that this information may assist you to decide for yourself what the object might have been.

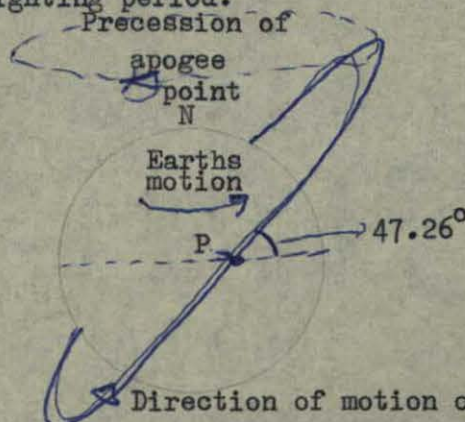

I am an interested observer of the Baloon Satellite. I have followed it ever since it was launched in August 1960. I am not in any moonwatcher's club, just a housewife with a husband and family of 3. Although I have gathered certain data of Echo, I still am puzzled on certain points. I wonder if you could spare the time to tell me what I want to know?

First, is it taking the same time to circle, as it did 3 years ago? Recently as it came up over the S. West Sky, it came exactly to the 2 hours, but before that it seemed to take about 5 minutes or so under that time. My last sightings were

11th June 6.10 P.M. & 8.10 P.M.

12th " 7.10 P.M.

13th " 6.10 P.M. again. (14th, Cloudy.) gone.

For nearly 3 weeks I watched it, and each time I saw it at these times - either at 7 or 10 minutes past 7 one night, & the next, and so on. It had never been so regular at all. In our local Cairns Post, the clipping I have from your quarter tells it would be seen at 8.15, but it was 8.10 here, and ever after, 7.10, 8.10, 9.10, etc.

I have tried to calculate when I will see it again at night. I make it that in 12 weeks, with a day sooner or later, it will be back in the same position. It must be coming over now in the early mornings, but nights are cold. If you could tell me when to look out in the next 2 or 3 weeks, early morning, I would look. By end of July it should be in the night sky again, is that so?

I noticed this: - in winter it is seen earlier, & for a shorter time than in summer. As it goes from view, it loses or gains time as it changes position, for example, it is dead on the 2 hours all the time, but if I try to calculate when I shall see it again, after a long time, I am always $\frac{1}{2}$ hour out. It seems, every 12 weeks it is in the same position, but $\frac{1}{2}$ hour later. I can't figure that one out. Again, when it finishes going from west to east, it disappears for only 7 to 9 days, & comes back again for 20 days, S. W. to N. E. I have seen it several times only in the early mornings, by chance. When it finishes being seen at night, do you see it in the morning immediately, or 2 weeks later?

Please excuse my blundering questions, but I am very interested in the satellite, it seems like a friend, and I have pointed it out to many people who had never seen it. Kind regards,

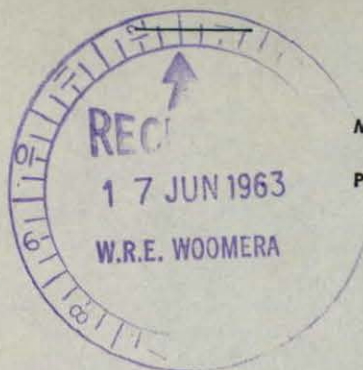



1. Subtended is a report submitted by Scientific Observers concerning an observation at 1858 hours on 17th April :-

"At 1858 hours on the abovementioned day the TM Trials Team observed a luminous region in the sky bearing 090° M. from building TM 1 at an elevation of approximately 20°, adjacent to a star at this bearing, at a magnitude of approximately 2.

One minute later a series of short duration (less than $\frac{1}{4}$ sec) flashes occurred at approx. 2 second intervals, each flash appearing at a vertical separation of about 2" below that preceding it.

Subsequent to this a patch of luminosity, subtending about 1° was observed lasting about 1 minute.

A theodolite and hand bearing compass were set up to determine the bearing and altitude of the star referred to above on the following day.

This star did not appear despite a clear sky. "

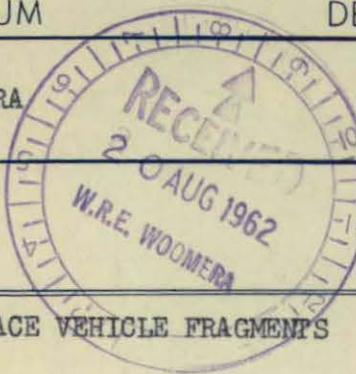

IDENTIFICATION OF SPACE VEHICLE FRAGMENTS

A letter has been received from the Department of External Affairs stating that the United States Embassy has informally sought their assistance in obtaining information which might be used in the identification of space vehicle fragments. The Embassy stated that if a luminous object is observed in the atmosphere and/or fragments are recovered which might be associated with the re-entry or earth impact of space vehicles, the following information would be helpful in identifying the vehicle and determining its origin :-

1. Observation of Luminous Objects

- (a) Date and time of the observation(s).
- (b) Location of the observer(s) (city, town, etc. or geographic coordinates).
- (c) Trajectory or flight path of the object (compass heading) and its location relative to observer(s).
- (d) Burning characteristics, i.e. colour; whether light was steady or pulsating, whether streamers were emitted (sparkler effect).
- (e) Was break-up of the object observed? If so, the estimated geographic coordinates, locating the point of break-up.
- (f) Was noise associated with the flight?


2. Observation of Impact(s) and/or Recovery of Fragment(s)

- (a) Date and time of impact(s) or recovery of fragment(s).
- (b) Location of observer(s) and/or coordinates locating area where fragments were recovered.
- (c) Dispersion of fragments within the recovery area.
- (d) Was noise associated with the impacts?
- (e) If impacts were not observed, but heard, the date and time of noise.
- (f) Physical description of the fragments, i.e. length, width, thickness, weight, condition, etc.
- (g) Description of any numbers, letters, inspection stamps, or other identifying marks on the fragments.
- (h) Nature of terrain - wooded, sandy, pasture, etc.



PO/SRS and PO/R at Woomera have been asked to report on such occurrences seen by members of their staff. Other people in the Woomera area may also notice this type of phenomena. When any instances are brought to your notice would you please arrange for as much of the above information as possible to be sent to the Superintendent, Optical Instrumentation Division, Salisbury. Before the report is submitted proper consideration should be given to ensure the phenomena can be reasonably judged to have been caused by the space vehicle rather than meteors, balloon sondes, aircraft, fuel tanks or other items jettisoned by aircraft, etc.

No special effort is justified in order to obtain these reports.



I passed on the information by letting the others read your letter.

Subsequent to that extraordinary sighting of what looked like a fourth to the normal three of Orion's Belt we found it on four, if not five occasions after that with one miss in the middle due to cloud. In these cases it rose north of Achernar each time with not much apparent difference in the arising site but it then went through the Southern Cross several times and each time getting more north of it till well north and the last time we were able to find it.

I think we were all a bit surprised to think that the thing we saw moving was at its earliest over S.W. Queensland and at latest beyond New Zealand.

LOCATION of POINT of OBSERVATION.

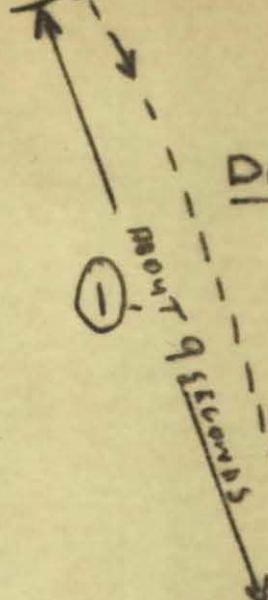


MAP OF TARGET COURSE

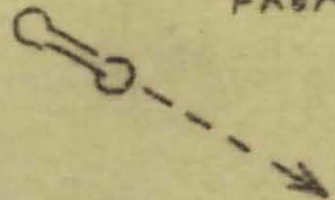

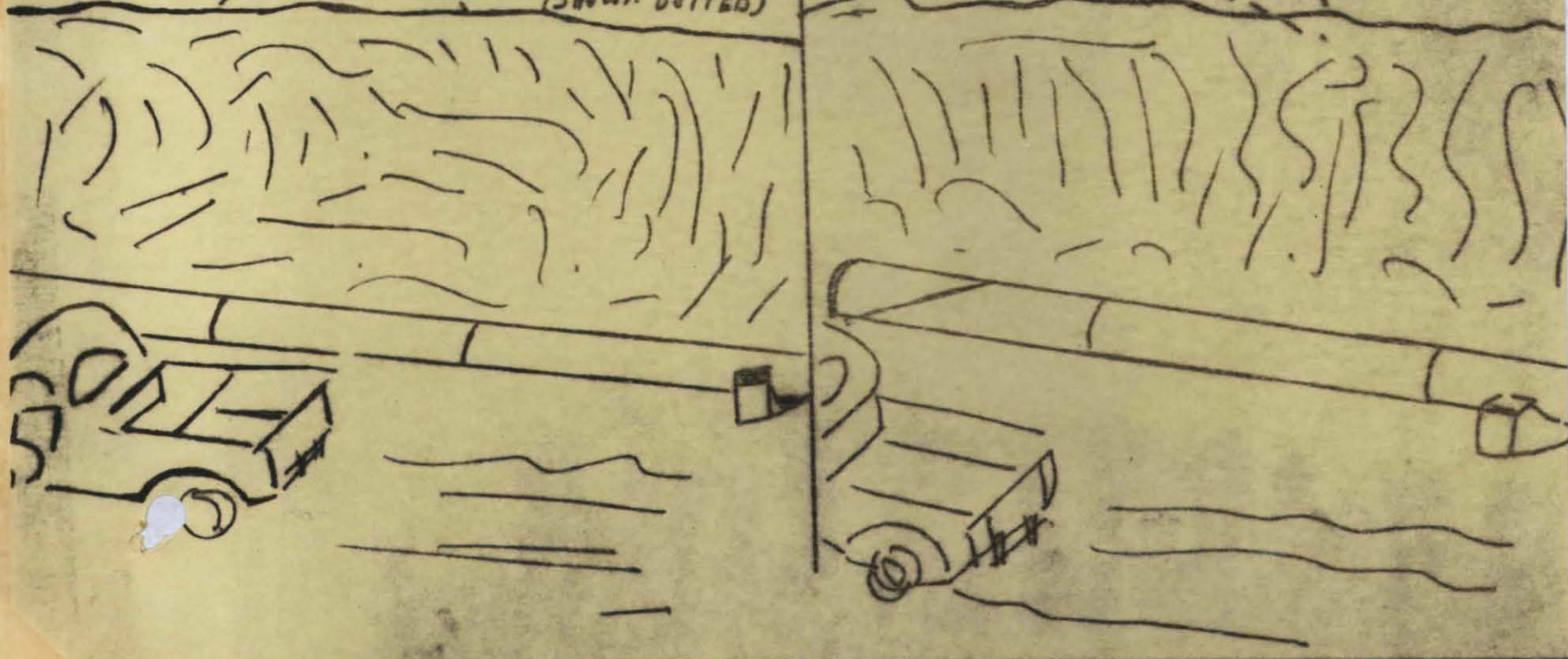

Dear Dr. Scott,

You undoubtedly saw the American Echo satellite on the evening of March 6th. From your location, Orion's belt, at 7.30 p.m. E.S.T. would appear 25° W of N. at an elevation of about 53°. The Echo satellite at that time was over south-west Queensland at a height of 950 miles and travelling south-east at a speed of 15,850 m.p.h. (264 miles per minute). By the time you lost sight of it at about 7.40 p.m., it was well east of New Zealand, having passed over Newcastle, the Tasman Sea and the South Island of New Zealand.

This satellite is a balloon 100 feet in diameter made of very thin Mylar plastic sprayed with aluminium, and is used in communications experiments simply as a passive reflector of radio signals. It circles the earth every 116.3 minutes in an orbit which is inclined to the equator at an angle of 47.3 degrees.

You will appreciate that its very slow apparent motion is on account of its distance, its range from you on the 6th March being from 1,000 miles at its closest to probably 3,000 miles when it disappeared from view.

Dear Sir,

I would be obliged if you can tell me what it was we saw here last night: -

I was out in the garden and on looking at the Constellation of Orion was just telling myself that this is nonsense - there ought to be only three stars in the belt and thought I was seeing things and quickly thought surely I am not a lucky witness to a nova. By then on standing quite still I could see then that it was something moving. So the four stars (the odd man was on the left of the fixed three) for a time were in that odd position of shewing four in line. By the time I had run to the neighbours after going in to call my wife it was obvious it was moving at a majestic sort of pace. So we all watched it to see if it would score a bull on Sirius but I think it was a near miss, low. I followed it east by south till it disappeared about 15 deg. above the horizon due to high trees not far away.

So that will give you a pretty exact line to follow with the time stated to be as near as can be put about between 7.30pm. and 7.40pm and probably not more than 7.35 when first sighted.

It was brighter than Rigel, the three of the belt and Betelgeuse and Aldebaran but at first sighting not so much superior to the three of the belt (it made me think it was just such another as the three). It was like a highly polished golden sphere reflecting the light back to us. Maybe having looked at it with a 10x50 pair of binoculars memory of its brightness goes a bit to that view so let us revert to the naked eye which thought it about a mate for the three of the belt.

A sweep of the western sky did not reveal the Suke to me. I was running a line about 45 deg. mostly on the north-west sector which I could use.

At approximately 8.42 p.m. on Sunday 9/4/1961 we were fishing on the Thomson River approximately five miles above Longreach when the whole area was lit by a flash resembling that of lightning. With no storm activity in the area our eyes were naturally drawn to the clear sky. Almost directly overhead we observed an object travelling at high speed and leaving a white comet like trail to a point approximately 30 degrees above the Northern horizon where it petered out in a trail of red sparks. It travelled almost half the sky in a second or two. Approximately three minutes later a dull explosion was heard.


This may or may not be a natural phenomenon but the information is supplied in the hope that it may be of use.

Hoping we are not intruding on your time, which, undoubtedly you can use better than to be bothered with stories which must be of common cause to you, but to us the thing we saw, described underneath, was so inspiring that I could not do otherwise than to take the liberty to write to you, hoping you might be able to let us know what it possibly could have been.

On the night of the 4th of april, local time 3.14 hours, gmt 1944 hours of the 3rd of april, in position 05 degs 22 mins north and 119 degs 17 mins and 30 secs east in the near vicinity of Sandakan, British North Borneo, the 2nd officer D. Plooy, who was on duty at that time, called me over to the starboardside where he stood. He pointed out to me an object in the sky, approximately 2 to 3 degrees north of the star Vega and asked me if I saw it moving. At first sight I could not make out which of the two was Vega, as they were so close to each other and so much alike in magnitude and brilliancy. Then, as the 2nd officer told me, I saw that strange starlike object moving slowly through the sky in northeasterly direction. The 2nd officer took bearing and height of it, which were North 38 degs East and 47 degs high.

We could follow it going down to a height of 25 degs, where it disappeared behind the cloues and then again from a height of about 15 degs to 10 degs, after which it disappeared again.

We are sure that if the sky had been cloudless, it would have been seen going down over the horizon. The length of time it took to move from 47 degs to 25 degs was 7 minutes.

The following information is forwarded in amplification of verbal report of 19th November 1959 - your YA3/18/2 of 20th November 1959.

2. Mid-day of 19th November 1959, the undersigned interviewed Peter WALTON, acting Camp Manager, Mr. Eba, reference his report of the previous day to Flt./Lt. REES, R.A.A.F., that a helicopter had been sighted near Mr. Eba Camp.

3. Walton reported that -

- (a) At approximately 0949 hours on 18th November 1959, he had just walked outside the Mess Hut at Mt. Eba, when he heard the sound of a helicopter - he recognized the sound by "the beat of the blades".
- (b) He was accompanied at this time by Albert James GEORGE, employed as a stationary engine driver at Mt. Eba Camp.
- (c) He sighted the helicopter, full side on from the right hand side, over the top of a small hill located approximately S.S.E. of the Mt. Eba Camp (This is about 1 1/2 miles). Angle from eye level was approximately 30-35°.
- (d) The craft appeared to hover, dipped, and then moved upwards and away in a S.S.E. direction.
- (e) When he tried to direct George's sight onto the craft, George, although he could hear it, could not see it.
- (f) During service with the auxiliary Coast-guard in U.K., he had frequently seen helicopters (Sikorsky craft), and at the time he thought this was one of that model, because it was a distinctive orange colour - similar to that colour used on Air/Sea Rescue helicopters.
- (g) The length of time of sighting was estimated at 10-12 seconds.

4. When shown a copy of Green and Pollinger's "Aircraft of the World", Walton stated that the helicopter appeared not as deep as an LAR3 Type 36 "Hound", more of a cross between a Bristol 171 Mk 4 and a Bell 54 (XH 15).

Thank you for your letter of 6th September, 1959. I very much appreciate your action in taking the trouble to write to this Establishment on your sighting.

The object you saw probably was not a satellite. The dying stages of satellites can be predicted with reasonable accuracy and none were due in at this time.

The object was most likely meteoric in origin. Your description of the glow effects and speed is remarkably similar to reports on objects sighted in recent months here at Woomera. The apparent slow speed - much slower than normal meteors - could be explained by the aspect of the trajectory from your viewing point. In other words, the object may have been approaching almost directly towards you and the angular speed was therefore low.

It is appreciated that there is much which remains to be explained on the matter of natural objects and their approach through the earth's atmosphere. Thus the opinion expressed above is not necessarily correct. However, I think you may take it as highly likely that the object was not man-made.

Dear Sir,

Last Thursday night at approximately 9 P.M. I saw an object that could have been the casing of a sputnik falling through the atmosphere and burning up.

I first saw the object in the sky in the form of a glowing ball, more orange in colour than red, and not at all dazzling to the eyes. It was in the S. E. at between 30° & 40° ; falling in a S. W. direction at a pace comparable with that of a jet plane — not at an enormous speed. It looked to be only a few miles away & I would suppose a few feet in diameter.

Almost immediately after I saw it it emitted flame that trailed behind it for, I would say, some 50 diameters, finishing in fading tail as if tiny fragments were burning up. The object was obviously turning over, and the flame which was of a reddish yellow, ceased, but occurred again a second or so later & ceased again just before the object disappeared behind a high hill (Mt. Nelson). I phoned The Mercury soon afterwards & told them about it, but I have not located any

mention of it in print, so I decided to forward the information to you, as surely some people must be interested.

The evening was perfectly clear and I had a wonderful view of it.

I would suggest that I observed it for a period of from four to five seconds, during which period, as I have previously stated, it emitted two tails of flame, each identical with the other.

It is my opinion that the object would have hit the earth's surface not many miles away.

It would be most surprising to me if ~~it~~ it was not reported from further South. The Mercury spokesman said that there had been other reports.

I would like to know what you consider the object was? It was of course man-made & I should say definitely a casing.

I would suggest it could have been (say) six feet in diameter and was not more than twenty miles from here when it passed.

In the July 22nd, 1959 issue of the Baltimore Evening Sun the following appeared:

"FLYING OBJECT SPOTTED OVER ROCKET RANGE

Adelaide, Australia, July 22 (Reuters)- An Unidentified flying object, looking like a bright white badminton bird, was sighted over the Woomera rocket range in southern Australia Monday night, range authorities said today.

The object, sighted by trained staff, was traveling south.

It was not associated with any range firing, the authorities said.

Sightings of unidentified flying objects were reported at various other places in Australia the same night."

I thought that you would be interested to know that we saw an identical object-if not the same- at 7.04 PM the night of January 25 in the Pacific Ocean off Panama. There were eleven of us, including two crew, in the Pescadora on a fishing trip out from Balboa in the Canal Zone. We anchored back of Pescadora Island, one of the Las Perlas group for the night, which is situated about 75 kilometers south east of Panama. It was a black night and one of the passengers said "look at the jet plane". We all looked and realized that it was not a plane because there was no noise and it was white with a stubby tail, the latter being about as long as the body of the object. We were facing north west so the object came from the south west and was traveling to the north east about 30 degrees above the horizon. We watched it for about 20 seconds and then reported it by ship-to-shore radio to the Information Center at Quarry Heights in the Canal Zone. When we returned on Sunday we were advised that a number of people had seen the object in the Canal Zone and it had been written up in the local newspaper. Due to information restrictions in the Canal Zone we could obtain no further information. However, in your official capacity, it may be that you can get this information from the Information Center which is located as designated "Quarry Heights, Canal Zone."



Superintendent, Woomera:

At 0900 hours on 24th June, it was noted that there was a large amount of interference on the P.P.I. of the No. 4 Mk. 7 Radar situated on Range "E". This interference was between 30,000 yards and 80,000 yards, and between bearings of 305°T and 035°T. The elevation was below 25°.

At 0940 hours this interference had shifted, and was between 40,000 yards and 120,000 yards (the maximum range of the radar) and between bearings of 360°T and 100°T.

All interference had vanished by 1030 hours. The only cloud in the area was approximately 4-5/8th cirrus in the Northern portion of the sky, and was not of the type which would normally give any 10 cm. radar reflections.

The wind at cloud height was approximately 287°/142 knots.

This information may be of interest to the air support squadron at Edinburgh.



REPORT ON A FLYING OBJECT SIGHTED ON 5TH MAY, 1954.

I was at Range R1, (Post R1), the Radar Post, standing by the Security Officer's Hut, and looking towards the Radar Post at approximately 1645 hours, observing one of our trials through binoculars.

This object appeared to be travelling towards me or directly across a path of the approaching Canberra. When it got to the path of the Canberra it turned to my right and was going in the direction from which the Canberra had just come.

When it got directly over the Canberra it slowed down. During this time I found it very hard to believe what I was seeing, so I shut my eyes and then looked again through the binoculars and the object was still stationary over the flight path of the Canberra.

Since it appeared to be the same relative size as the Canberra through the binoculars, I thought it would be possible to see it with the naked eye. However, when I looked over the top of the binoculars the object had either gone or I could not see it with the naked eye, and when I looked again through the binoculars I could not pick it up.

The object appeared to be travelling about three times as fast as the Canberra, but of course it is impossible to estimate, since I did not know what height it was. It was perfectly circular all the time and a dark grey colour, and gave the appearance of being translucent. It did not glisten at all when it turned or was it shiny.

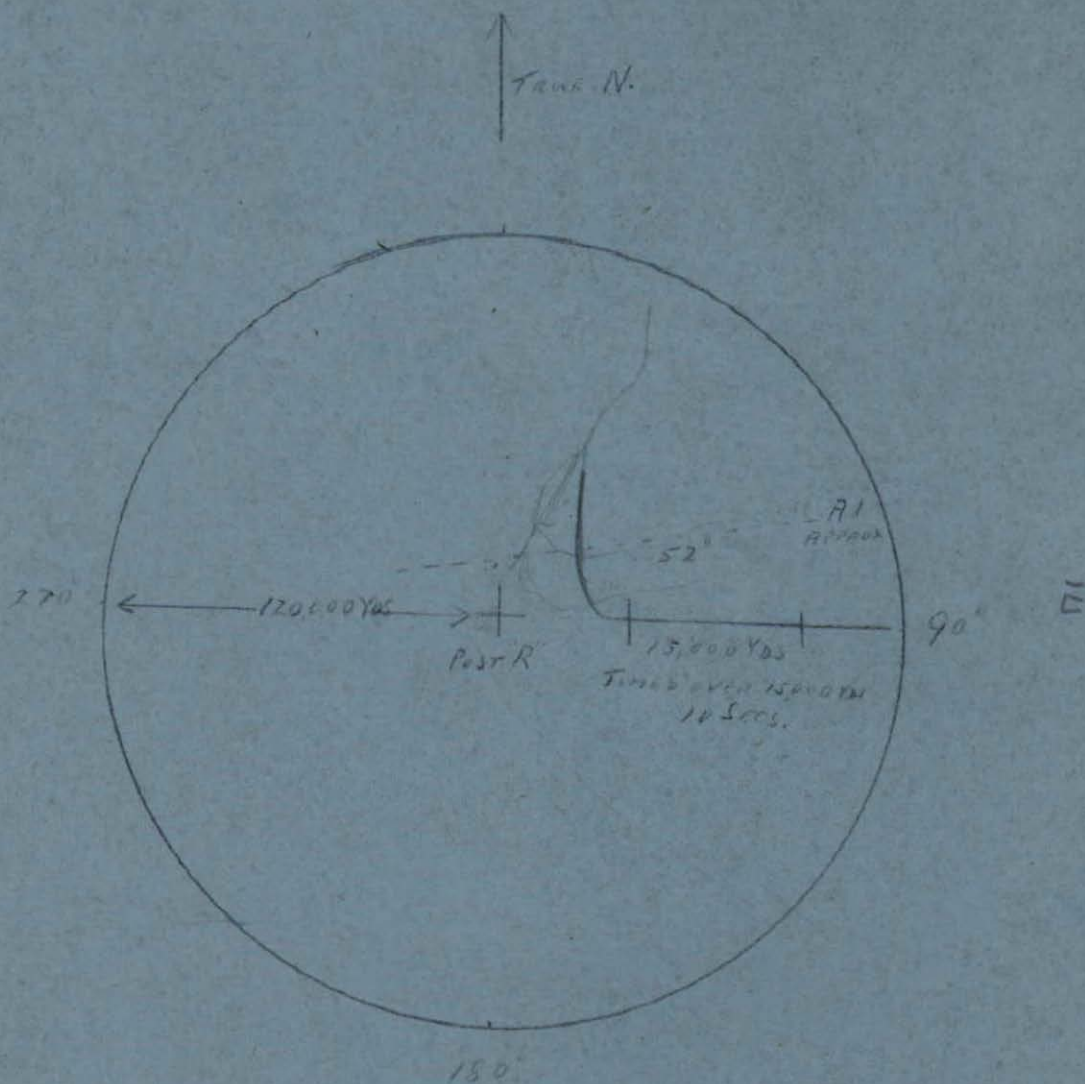
At about 1800 on 5th May, an unidentified Target was observed on Radar AA Number 4 Mk 6.

The target appeared on High Beam at a range of about 60,000 yards Brg 355 approaching "R", described a Hyperbola over "R" and went out at a bearing of approx 90°. On its way out it passed behind Spotting Tower, "32". I timed it over 15,000 yards in 10 seconds which would make its speed approximately 3600 M.P.H. Cfn. KEANE observed this occurrence with me. 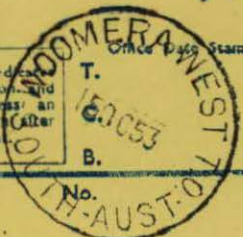

From the Trials Officer, Range "A", had scanned the sky with binoculars for approximately 20 minutes on the afternoon of 29th July but had seen nothing.

7. It was ascertained that during Trial Number 383 held on the morning of 29th July a round object had been mistaken for a bomb being released by Lincoln aircraft engaged in the trial and a series of photographs had been taken. These are normally despatched to Salisbury. Mr. R. Polkinghorne, O.I.S.C. advised S.O.O. to teletype Mr. Watson, P.O.B.R. to examine films of Trial 383 and ascertain if any objects appear on the negatives.

8. Deductions as to nature of objects.

Taking into consideration the following factors -

- (a) No interference on radar screens, on range.
- (b) No interference with electronic equipment.
- (c) The fact that in most cases objects could only be seen through binoculars of 10X magnification.
- (d) The apparent high speed of the objects indicating possible low altitude.
- (e) The small size of the objects.

It is believed that the objects seen were balls of thistle seeds and vegetation which, during certain periods of the year collect on the ranges and roll along the ground propelled by the wind. These balls of seeds sometimes are blown into the air and are carried along by air currents to considerable height.

In the absence of photographs or further information, and no samples of the objects being obtained on the day in question, it is proposed that investigation be postponed pending any further advice from Salisbury.

REPORT

CONCERNING UNIDENTIFIED AIRCRAFT SIGHTED
ON 29TH AND 30TH JULY, 1953 IN VICINITY
OF TRIAL RANGES BY SECURITY OFFICER OPERATIONS.

INTRODUCTION.

1. Following two reports concerning unidentified aircraft sighted in vicinity of Evettsfield on 29th and Range "A" on 30th July a preliminary report on the investigation was made by the Security Officer Operations follows below -

2. Incident Number I at Evettsfield.

An unidentified aircraft was sighted by F/Lt. F. Barnes through binoculars at 1205 hours on 29th July on a bearing of 180degrees while F/Lt. Barnes was at Evettsfield hanger. It was a considerable distance away and it was not possible to ascertain its type or number of engines. Radar at Evettsfield also recorded the aircraft. This matter was not reported to Security Branch at the time.

Inquiries made with Filter Room revealed that no aircraft belonging to L.R.W.E.R. were in the vicinity at the time.

3. Incident Number II at Range "A".

At 1010 hours an unidentified aircraft believed to be a Mustang was sighted from Post "CH" Air Ranges by several persons including the Trials Officer, (F/Lt. Banks), Security Officer Operations and Local Security Officer, Air Ranges. It appeared to be stunting over the centre line between Camera "B" and Kine "J". Its altitude was approximately 4,000 feet. It was also heard by persons who saw it. Radar on the range recorded its presence. The aircraft was stunting and did a roll, a dive and a loop. Inquiries made with the Control Tower, Woomera, A.R.D.U. and Control Tower, Evettsfield failed to identify it as an aircraft belonging to L.R.W.E.R. Further inquiries made with Air Control Officer, Parafield who controls movements of all aircraft from Adelaide to Woomera area also failed to reveal any information to identify the aircraft in question.

At the time the aircraft was sighted the Lincoln was up at height preparatory to making a live bomb run on the target at Range "A".

4. It is considered that the matter is of a serious nature and needs a full investigation in view of -

- (a) the nature of the project at range extension.
- (b) the fact that trials were in progress at Air Ranges.

5. It is recommended that -

- (a) all personnel on ranges be advised to watch for a recurrence of this incident.

- (b) That Peace Officers be instructed to look out for any strange aircraft while on duty on Ranges at all times.
- (c) That A.R.D.U. have provision made for an aircraft to be made available to stand by in case of further incident in order that strange aircraft can be tracked and identified.

6. A signal has been sent to X200 requesting information dealing with the reported incident.

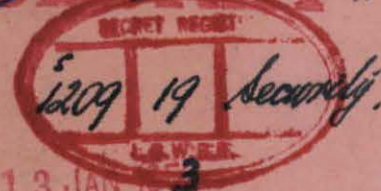

FLYING SAUCER PHENOMENON OVER RANGE "G1"

In further inquiries made regarding the above subject Mr.G.Trefry, Meteorological Officer, has been interviewed. He states that such phenomenon has occurred before and has been known to affect radar. It is believed to be caused by ice packs at certain altitudes.

2. A summary of the weather for 8th October is given as follows "Fine, 5/8 high cloud 25,000 ft., warm temperature, 84F., strong northerly wind 25-30 m.p.h."

3. In view of the foregoing and in the absence of anything visible to the reporting Warrant Officer it is probably that the signals came from a cloud as described by Mr.Trefry.

"FLYING SAUCER" PHENOMENON OVER RANGE "G1".

Resultant from a report submitted by W.O.II MILLWARD G.E. regarding an invisible phenomenon which registered on his radar station at Range "G1" on 8th October, 1952, this officer has conducted inquiries among other Radar Operators with a view to gaining further information. To date, however, nothing useful can be added to W.O. Millward's version (Appendix "A").

2. It will be observed from the time/height log in W.O. Millward's report that the phenomenon was locked to his radar beam for a period of at least twentyfour minutes which can in no way be compared with the alleged "flying saucer" phenomenon of previous reports. The height ranged from 1500 to 5600 feet during the time involved.

3. Inquiries made among other Radar Operators, particularly F/Sgt BIRKETT D., attached to Range "G" revealed that it is most probable that the snow cloud had some connection. However, the possibility of a neutron cloud is not ruled out and the fact that small portions were breaking away tend to show that whatever it was the radar was registering the target very efficiently on something other than ordinary snow.

4. As it is definite no object was visible there is nothing of security interest. The plan and report are submitted for record purposes.

Report Submitted by W.O.II MILLWARD

At 1345 hours whilst searching for a Mustang on G1 a target was locked on to the above, the Shell Lagoon area. On looking through the telescope on radar dish (also visual tracker) no target could be seen (Radar Range 3000 yards).

The signal to noise ratio was at least 5 to 1 which is similar to that obtained from a large aircraft. At one time between 1345 hours and 1400 hours the target came within 1 mile distant and still no target was to be seen.

At 1405 hours I decided to plot the course of the target, this can be seen on the attached map.

At times during the movement of the target smaller targets seemed to detach themselves from the main target and drift away.

Subject: "FLYING SAUCER" OBSERVED OVER WOOMERA.

This officer reports investigation of information of an object alleged to be a "Flying Saucer" seen in the sky at about 2100 hours on Saturday, 27th September, 1952.

2. Statements have been taken from the following persons as a cross section of a reported number of people at Woomera who also observed the object:

3. The first four named above were at the Woomera West Theatre when Sgt. Phillips sighted the bright object in the sky. He drew the attention of W/O Hanley to it and he in turn nudged W/O Walker. In the meantime Phillips had informed Ager and all four were able to see the phenomenon before it was obscured by the projector tower after it had traversed the sky from a line to the right of the screen. This shows that the object was visible for several seconds as it traversed the sky on an even keel parallel with the earth.

4. Mrs. Dean was standing with her five-year-old son at the corner of the Junior Ranks Club on Central Avenue when the child drew her attention to a light. She thought he pointed to a motorcar light on the road near Woomera West in the distance but the boy corrected her and she saw the bright object as it travelled well above the horizon until it left her view over the horizon past the Phillips Ponds. Mrs. Dean stated that the time was about 2100 hours.

5. In each of these cases the persons concerned were quite sober and of responsible type therefore, no doubt exists regarding what they saw. This is further borne out by reports from other parts of South Australia examples of which are attached from "The Advertiser" Adelaide, under dates 29th, 30th Sept. and 1st October, 1952.

I was one of a party of four D.I.D. personnel who
attended the Woomera West Open Air Theatre on Saturday, 27th
September. The others were Sgt/Maj.Walker and two others.
I have just arrived up here myself. Sgt/Maj.Walker will give
the other names.

Some time after the show started Sgt.Phillips, that's
his name, nudged me on the arm and said "Look at this". I
looked from my position on the left of the Projector towards the
right of the screen and in the sky, well above the level of the
fence round the theatre, I saw an illuminated object shaped like
a cigar with a spurting light at the rear travelling from West
to East in a horizontal way. It was travelling in an even keel
and was observed until it was out of sight. As I saw the thing
I then nudged W/O Walker and remarked "Look at this" at the same
time pointing in the direction of the object. I would say that
the object was visible to me for about five seconds. I did not
hear any noise as the picture show may have drowned any.

Comparing the object with a shooting star I would say
that it was definitely something other than a shooting star or

Statement of W/O 2/46902 WALKER A.F., D.I.D., Woomera, made at 1910 hours, 28th September, 1952, and taken by J.A.McCahey, Assistant Security Officer, Woomera.

I was with W/O Hanley, Sgt. Phillips and Mr. Ager at the Woomera West Open Air Theatre on Saturday, 28th September.

At between 2045 and 2100 hours W/O Hanley nudged my arm and said "Look at the rocket". I looked directly right from my seat on the left front of the projector and saw the object and said "That is not a rocket". It was cigar shaped tapering off towards the back. It was lit up like a neon light with a haze around it. The colouring was whitish and the exhausts or flames at the back were yellowish or cream. I have no idea of the height but its size to me looked eighteen inches to two feet but comparing it with an aeroplane the size and height would be about the same as aircraft I have seen. From my position I would say the angle was 40 to 45 degrees. From the time I first saw the object until it went out of my sight I would say the time elapsed would be three seconds.

I have observed fast aircraft, meteorites and shooting stars. This object was travelling on an even steady keel faster than any aircraft I've seen but not as far as the falling star besides this object was travelling horizontally south-west.

Statement of Mr. Joseph AGER, baker, employed by the Department of Supply and attached to D.I.D., Woomera, made at 1940 hours, 28th September, 1952, to J.A. McCahey, Assistant Security Officer.

I was with W/O's Walker, Hanley and Sgt. Arthur Phillips at the Woomera West Open Air Theatre.

We four were seated on seats back from the Exit Door on the left of the Projector. At about 2050 hours, the time was checked by Sgt. Phillips. Sgt. Phillips said to me "Look around to your right Joe, what do you think that is?" I looked and saw a peculiar object which I thought shouldn't be up here, it was travelling at such speed - faster than any of the jets up here. It was of a dark greyish colour and of airship shape. I thought that the lights being emitted from the stern were more yellow than the remainder. The object was travelling on an even-keel at between four to five thousand feet. I gauge this height from experience of flying. The direction of travel was s/south-west. It was in view to me for only two to three seconds and during that time it kept its definite course.

From my experience of aircraft of different types, meteorites and stars I have no hesitation in saying that this object was man made.

Statement of 1/9043 Sgt. PHILLIPS, A. attached to D.I.D., Woomera, taken at 2010 hours, 28th September, 1952, by J.A.McCahey, Assistant Security Officer, Woomera.

I accompanied W/O Hanley, Walker and Mr. Ager to the Woomera West Open Air Theatre on Saturday, 27th September, 1952.

At about 2050 hours we were seated on the left side of the theatre facing the screen and about third of the distance from the screen. My attention was drawn to a movement in the sky over the right hand corner of the theatre fence. I observed a cylindrical shaped object with what appeared to be two port holes with internal lighting. The whole had a lightish grey colour, the size appeared to the eye to be four to five feet. A Lincoln travelling at night at the same angle looks much bigger. It was moving on an even keel, horizontally from north-west to south-west, and at a height of about the height of the theatre fence doubled.

The object had moved some distance before I nudged W/O Hanley. I said "Do you see that", and pointed. I turned right and remarked to Mr. Ager, "See that".

The object was travelling fast - faster than any jet aircraft I have seen. It is difficult to estimate the speed especially at night.

I am not prepared to say whether this object was an earthly object, but it was a fuselage of some kind.

I have discussed this incident with Ager who shares room with me because we thought we had something which should be reported. I have today made a rough sketch setting out my impression of what I observed.

any of the jet planes here and appeared to be travelling at about
the same height as they usually fly. I could not discern any
particular shape but thought the light was reflected off the object.
I do not think it came from the heavens because it looked like a
manufactured thing.

I told my husband when he returned and he said, "I wish

"FLYING SAUCER" - ALLEGED OBSERVATION OF

This officer reports on continued investigation of unusual object observed in the sky by Peace Officer First Class Newell G.M. on 29th April, 1952 (See Appendix "A").

2. Several bus drivers were interviewed before the reporting officer identified the other witnessing person as Mr. Norman Henry GREGORY, Driver, Department of Works & Housing, Koolymilka, Pass No. 6147. He stated that he was at Woomera West Siding on the morning of 28th April and whilst awaiting arrival of the Budd Car sat in a Vanguard with Mr. W.H. Tomlinson. He said a Peace Officer was also in the vicinity. About three-quarters hour prior to the arrival of the Budd Car he observed an exceedingly bright object passing along the sky from South-east to West. He said he had never seen anything like this object before and compared it with a very-light but ruled that such could not be the case because of its great height, distance of travel and the speed which was faster but not nearly as fast as the usual shooting star. Remarks were passed between Tomlinson, possibly the Peace Officer and himself whilst the object was in flight.

3. Mr. William TOMLINSON, employed by WILCKENS and BURNSIDE, Woomera, Pass No. 4870, has been interviewed. He corroborates the information of P.O. 1 Newell and Mr. Gregory. He stated that he looked through the windscreen of his car and observed the object travel horizontally across the sky from approximately South to West. It headed slowly towards earth. It was much larger than anything he had ever seen in the sky but did not move so fast as a falling star. It was not nearly so far off yet, probably, could have fallen to earth outside Australia. Asked by this officer if Mr. Tomlinson thought the object could have been manufactured on earth he said "Definitely not".

4. Mr. George Trefrey, Meteorological Officer was interviewed and the facts as obtained given with a request for observation on the subject. Mr. Trefrey intimated that it was a peculiar thing that no Met. people ever observe "flying saucers". He checked his records and found that

there was some light cloud known as Stratus-Cumulus at about 2500-3000 feet moving at about 18 knots. There was a new moon which would be high in the sky at about 0330 hours, 28th April. He was sceptical of the phenomenon observed and put forward a possible answer saying that under circumstances with cloud similar to that on the occasion the powerful headlights of a moving car could be reflected in the cloud.

5. P.O.1 Newall was interviewed regarding the possibility of the object being a reflection of car lights turning a corner. He is definite that the object was in the sky because he saw it pass behind the cloud as well as in the clear starry sky.

6. In conclusion this officer is satisfied an object, most likely a meteor, was definitely observed by the three persons Newall, Gregory and Tomlinson and, although the time differs, is similar to an object observed by a milkman in an Adelaide suburb on the same morning.

Subject : - Supposed "FLYING SAUCER" - Seen at Woomera West.

Sir,

In reference to the above subject, I wish to report that at approximately 0345 hours on the morning of Monday 28th April, 1952, while waiting at Woomera West for the arrival of the BUDD car, I saw a very bright light in the sky. It was approximately 45 degrees above the horizon, in a South Easterly direction from my position when I first noticed it, and moving in a West North Westerly direction, keeping parallel to the ground. The sky was overcast and it had been raining earlier in the morning, but the light lit up the clouds, like that of a full moon, also the countryside was reflected by its brilliance. The light was visible through breaks in the clouds several times, and was the same color as a Meteor, and appeared to be the size of 1/3 of a full moon, and it was a good 15 seconds from the time I first noticed it until it disappeared in the distance.

As Bus driver remarked that "They are firing Rockets early this morning" and I remarked "That it was not a Rocket".
