This is the final response to your Freedom of Information Act (FOIA) request, originally received by the United States Secret Service (Secret Service) on September 26, 2016, for information pertaining to a copy of all records related to Donald Trump's comment, "If she gets to pick her judges, nothing you can do folks..." Although the Second Amendment people-maybe there is, I don't know", to include any investigations, reports, letters, memos, emails or correspondence between U.S. Secret Service and anyone affiliated with Donald Trump.

Enclosed are documents responsive to your request. In efforts to provide you with the greatest degree of access authorized by law, we have considered the reference material under the FOIA regulation, Title 5 U.S.C. § 552. Pursuant to this Act, exemptions have been applied where deemed appropriate. The exemptions cited are marked below.

In addition, approximately 133 page(s) were released, and approximately 0 page(s) were withheld in their entirety. An enclosure to this letter explains the exemptions in more detail.

**FREEDOM OF INFORMATION ACT

Provisions of the Freedom of Information Act do not apply to matter that are:
